## Pension application of Thomas Morrell S4241 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Tennessee, Sullivan County}

On this 3 day of May 1833 personally appeared before me William Rockhold a Justice of the Peace for the County aforesaid, Thomas Morrell a resident of Sullivan County Tennessee, aged Seventy two years who being first duly Sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup>, 1832. That he entered the [Service] of the United States a drafted militia man in the year 1780 late in September under Captain Pemberton [John Pemberton] in Colonel Shelby's [Isaac Shelby's] Regiment and marched to Kings Mountain in South Carolina and was in the heat of the engagement at Kings Mountain [October 7, 1780], and served two months said tour when he entered the mare he took with him was appraised at fifty Dollars and died in the service for which he never Received any pay Deponent says that he was verbally discharged as was all the company that he served with as he believes: Deponent further saith in about two or three weeks after returning home from Kings Mountain he substituted for Jonathan Morrell for a two month's tour and marched to Big Creek Station then on the frontier of next to the Cherokee Indians who were in alliance with Great Britain and at war with the United States and served said two months under Captain Koil [Robert Kyle] & Lieutenant Asher [Charles Asher] and saith he was made an Indian spy by said officers and served said two months for which he substituted principally as a spy and when his term of service ended he volunteered for one month longer under said officers (Koil & Asher) and did serve said months agreeable to his enrollment and was continued as spy for said term of service with Elijah Chison [Elijah Chesson?] between Bulls Gap & Big Creek Stationed and Deponent says said tour at Big Creek he faithfully as he believes served three months and was verbally discharged.

Deponent further saith very shortly after he returned home from the last mentioned tour he was drafted for a two months tour in the year 1781 to go to the Cherokee Nation and marched under Captain Rutledge [perhaps George Rutledge] [of] Shelby's Regiment as far as Richland Creek at which place they [sic, the] Army met with a party of Indians coming in suing for peace and the Army was then continued pending the negotiation and at some period of said negotiation the Army was ordered back to Big Creek Station and there continued to the expiration of our term of service and again was verbally discharged immediately on coming home say in a few days substituted for William Odell there and went back to Big Creek Station and served two months the term for which he substituted for under the aforementioned Captain Koil & Lieutenant Asher and resumed the duties of Indian spy and served said two months and was again verbally discharged Deponent does say he served in the revolutionary war nine months or


more and as he believes faithfully discharged all the duties assigned to him and if he ever had any written discharge he does not recollect it and further says there is none in his possession but does most confidently believe that he was verbally discharged from every tour of Duty that he served as above mentioned.

Deponent says he was born in the State of Jersey [New Jersey] \_\_ County in '60 or '61 and that he has no record of his age. He says he lived in Sullivan County Tennessee then North Carolina when called into service where he has ever since and does now live within a mile of the same place he further saith that he served as a drafted militia man as a volunteer and as substitute one tour for Jonathan Morrell & the other for William Odell.

The tour to Kings Mountain Cols Shelby [Isaac Shelby] Cammel [sic William Campbell] Sevier [John Sevier & Cleveland [Benjamin Cleveland] was at Kings Mountain Shelby Koil & Asher with others not recollected were with him in his other service the only material circumstance at Kings Mountain was fast traveling, hard living & hard fighting but did not last long and we whopt [sic, whipped] the enemy the other part of his service was close watching and trailing the Indians. Deponent says he is acquainted with all most every man more or less in this County and many out of the County except some of the young & rising generation and that he is proud to say he does not know of any person with whom he is acquainted that would doubt his veracity or the truth of his statements when on oath or otherwise – further he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of any State or territory.

Sworn to and subscribed the day and year aforesaid State of Tennessee Sullivan County. S/ Thos Morrell, X his mark

[Wm Carr, Edward Hicks and Nath'l Morrell gave the standard supporting affidavit; in addition, "...William Carr¹ says he served the tour with the applicant set forth in his declaration to Kings Mountain and knows his statements to be correct on that part of his service and the balance he believes is correct on that part of his service and the balance he believes is correct."



[Veteran was pensioned at the rate of \$36.66 per annum commencing March 4, 1831, for service as a private for 11 months in the North Carolina militia.]
