## Pension application of John Campbell S42640 Transcribed by Will Graves

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of Ohio, Muskingum County

Be it known, that before me in the State and County aforesaid personally appeared John Campbell and made oath, that he is a resident citizen of this State; that he served as a private soldier in the Revolutionary war against Great Britain; that he enlisted on or about the 1 May 1777 for and during the war, in Captain Hornsby's Company, fourth Regiment, Virginia\* Line, on the Continental establishment – that he was discharged at Savannah, in Georgia, by a discharge signed by Major Habersham, on or about the 1<sup>st</sup> of November 1781 – which discharge is lost – that he has no other evidence to offer – he is now in his 56<sup>th</sup> year of his age; & that in consequence of his reduced circumstances in life, he needs the assistance of his country for support.

State of Ohio Muskingum County

Be it known, that John Campbell having heretofore personally appeared before me, made oath, and satisfied me, that he served in the Revolutionary war against the common enemy, the proceedings had their own having been by me certified and transmitted to the Secretary of the Department of War; I, therefore, do now certify, that the aforesaid John Campbell has reappeared before me and satisfied me, that he performed the continued service of Nine months – and more – in the War of the Revolution, on the Continental establishment; that he is in reduced circumstances I am fully satisfied, and needs the assistance from the country for his support.

State of Ohio, Muskingum County: Court of Common Pleas, November Term 1820

On this 27<sup>th</sup> day of November 1820, personally appeared in open Court, being a Court of record for said state John Campbell aged 58 years, resident in Muskingum County in said State, who being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary War on the Continental establishment, as follows: In the Fourth Regiment, Commanded by Colonel John White – Captain Hoinby's [sic, William Hornby's?] Company Georgia Line. The date of my original

application is 1st of May 1818 and the number of my pension certificate is 10, 204. And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> of March 1818 and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of An Act of Congress entitled "An Act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary War," passed on the 18<sup>th</sup> day of March 1818; and that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed

My occupation is farming Not able to pursue it owing to disability of body and Rheumatism. The number of my family residing with me is two. Their names as follows: Eleanor, wife, and Polly, daughter. Their ages follows: 45 - 15.
