Pension application of William Leek S42853 Transcribed by Will Graves f10VA 9/21/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Cayuga County New York: I William Leek of the town of Locke County of Cayuga and State of New York after being duly sworn do Depose and Say that I was a private Soldier in the Revolutionary war and that I actually served as such three years on the Continental Establishment I Listed [enlisted] first for the term of one year in the town of Shernoka [?]¹ in the State of Pennsylvania in Captain Smith's Company of Rifle men and in Colonel James Chambers Regiment – I went with our Regiment to Boston and from there to Long Island – where my first Enlistment expired. I then Listed at Long Island for the term of 2 years under Captain James Parrs and in Colonel James Chambers Regiment of Riflemen – soon after (I enlisted in Captain Parrs Company) our Company was attached to Colonel Morgan's [Daniel Morgan's] Regiment of Riflemen and at the expiration of two years which I then Served – I was Discharged at the Camp near Piks Kill [sic, Peekskill?] – (after that I served two or three short Campaigns – at and about Schoharry [? Schoharie]²) and further I think the time of my first Enlistment at Shernoka was in the year 1775 and the time I was Discharged near piksill I think was in the year 1778 – the Regiment that I belonged to was called the first Continental Regiment of foot in the Service of the United States – and further that I am in such reduced Circumstances that I absolutely need the assistance of my Country for my support

On this fifth day of July 1820, personally appeared in open court being a court of record for the said County, William Leek aged 73 years, resident in Locke in said County, who, being first duly sworn, according to law doth on his oath declare that he served in the revolutionary war

Thernoka Lehoharmi as follows: in Colonel Morgan's Regiment in the New York line, Captain Bear's [?]³ Company that the date of my original declaration is 10 April 1818.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. And I do solemnly swear that my business has been that of a Weaver; but old age and bodily infirmities & particularly the newts [?]⁴ palsy disabled me from pursuing that or any employment & that my family consists of my wife Mary aged 72 years who is very sickly and infirm & requires much medical aid & my granddaughter Mary aged 13 years who lives with us to assist in our old days.

[Veteran was pensioned at the rate of \$8 per month commencing April 16, 1818, for service as a private in the Virginia Continental line.]

[Note: It does not appear that this veteran ever served in the South or ever lived in the South. I assume his application is indexed under the Virginia veterans erroneously and should have been indexed under the Pennsylvania veterans or New York veterans. The only theory I have as to how it ended up being indexed under the Virginia veterans is that the applicant refers to having served in Daniel Morgan's rifle Regiment.]
