Pension Application of Basil Nadeau S43063

STATE OF New York } Clinton COUNTY, ss. }

On this twenty ninth day of May 1819, before me the subscriber, one of the Judges of the Court of Common Pleas of the county and state aforesaid: Personally appears Basile Nadeau aged sixty seven years, resident in Champlain in the said county and state, who being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That the said Basile Nadeau enlisted in Albany in the state of New York in the company commanded by Captain Oliva [probably Lawrence Olivia] in the Regiment of Col. [Moses] Hazen in July or August 1776 that he continued to serve in the said corps, or in the service of the United States until the end of the war in May or June 1783 when he was discharged from the service in New Windsor state of New York; that he was in the battles of Staten Island [21 Aug 1777] Germantown [4 Oct 1777] Brandywine [11 Sep 1777] Brunswick & Yorktown [Siege, 28 Sep - 19 Oct 1781] and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services at this time. after his discharge Captain Hueldung[?] commanded the company & his discharge is lost Sworn to and declared before me, the day and year aforesaid.

At a Court of Common pleas holden at the Court-House in Plattsburgh, in and for the County of Clinton, and State of New-York, on the third day of October 1820 Present: Elisha Arnold, Caleb Nichols, Nathan Carver & Allen R Moore Esquires Judges of the said Court.

COUNTY OF CLINTON ss: On this third day of October 1820 personally appeared in open Court, it being a Court of Record proceeding according to the course of the common law, and having the power of fine and imprisonment, and keeping a record of their proceedings in and for the County of Clinton, Baszill Nadeau aged Sixty six years resident in the town of Champlain in the said County of Clinton, who being first duly sworn according to law; doth on his oath declare that he served in the revolutionary war as follows: that he the said Baszill Nadeau enlisted for the term of three years in the month of September 1776 at Albany in the State of new York in the company commanded by captain Olivia in the regiment commanded by Colonel Moses Hazen in the line of the State of New york on the continental establishment, that he was returned as enlisting during the War. that he continued to serve in the said Corps for six years & six months when he was discharged from the said Service in Boston in the State of Massachusetts that he was in the battles of Staten Island, Brandy Wine & White plains [28 Oct 1776]

that his original declaration to obtain a pension under the Act of Congress of the 18th of March 1818 was

made the twenty Ninth day of May 1819 that he has received a pension certificate Numbered 13682 and dated the twenty fourth day of June 1819 – And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

I am by occupation a farmer and as healthy as any man of my age. I have a son Francis Nedeau aged sixteen years who lives with me is well & able to work
