State of Ohio Hamilton County: Court of Common Pleas

On this 19th day of August 1824 personally appeared in open Court being a Court of record (expressly made so by the laws of this State) for the said County Randall Douglass -- aged sixty one years resident in said County who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision of the acts of Congress of the 18th March 1818 and first May 1820 that he the said Randall Douglass enlisted for the term of sixteen months sometime in the month of February 1779 at Orangeburg in the State of South Carolina in the company commanded by Captain Charles Lainning [sic, Charles Lining] in the Regiment commanded by Colonel Charles C. Pinckney [Charles Cotesworth Pinckney] in the line of the State of South Carolina on the Continental establishment, and that before this time expired he again enlisted, in the same Corps to serve for five years. And that he continued to serve in this Corps until the Capitulation of Charleston when, he was taken and detained a prisoner of war by the British for sixteen or seventeen months. This deponent further saith that he was in the battle of Stono and at the Sieges of Savannah & Charleston.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. And I do further declare under oath that I am a laborer occupation, that I have a wife living and 7 children, my children are so far grown up that they are capable of maintaining themselves. And finally I declare under oath, that from my age in indigent Circumstances I stand in need of the assistance of my Country for support.
