[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Territory of Florida County of Jefferson SS: In Superior Court November Term 1833

On this day the 27th of November A.D. 1833 personally appeared in open Court now sitting John Brown a resident of the County & Territory aforesaid aged seventy years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed 7th of June 1832 -- That he entered the service of the United States under the following named officers and served as herein stated --

That about the year 1778 he entered the service of the United States as a volunteer under the command of Captain John Converses [sic, John Convers] in the State of South Carolina -that he continued for about fifteen months in the Company of that officer. That John Freeman was first Lieutenant -- That he does not recollect the names of the second Lieutenant or Ensign of said company. That upon quitting the command of Captain Convers at the end of fifteen months he joined the Company of Captain Thomas Ray with whom he remained about [indecipherable word] months longer. That he does not recollect the names of others of the lieutenants or ensigns of Ray's company. That at the time of volunteering, he resided in the State of South Carolina in Barnwell district, near Coosawhatchie -- That from the place which he enrolled himself he marched to Mathews Bluff then to [indecipherable word, looks like "Pongatalligo" could have intended "Pocotaligo"]<sup>2</sup> -- from which point he was marched to the vicinity of Ninety Six and thence to Cuff [?] Town<sup>3</sup> from which place he was marched to Three Runs -- where he went in the direction and soon arrived at Mathews Bluff. That being only a volunteer and in the character of scout or spy he was not concerned with any regular engagements -- That he was not at any time under the command of any officer of higher grade than a Captain, and received no written discharge.

And the said declarant further states that he was in active service for about the space of two years & three months -- sometimes however permitted to return home, but soon ordered into service again –Yet [?] that he is entirely satisfied that he was on duty not less than fifteen months --

And he further states, he resides in Jefferson County and Territory of Florida above named and has resided there for near four years, and that before he removed to this Territory he resided in Georgia, Hancock County --

That he was born in the year 1763 in the State of Georgia in what was then as he believes known as the Province but now as the County of Screven -- That he does not know of any person residing in this Country, who knew him to have been engaged in the services in the United States -- That by reason of old age & consequent loss of memory he cannot state with more precision or definiteness, than as is herein above set forth, the facts and circumstances of his service -- But he refers [to] William Mathews Jr & Abram Bellamy Esquire as persons who are acquainted with him in his present place of residence, and who can testify to his character for veracity, and to the fact of his being regarded & considered in his neighborhood as a soldier of the Revolution --

He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension Roll of any State. William H. Mathews being absent at the moment Jesse Goodman is the minister referred to for character Sworn to in open Court
