[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Grant County: Sct.

On this 9th day of February 1833 personally appeared before one of the Commonwealth's Justices of the Peace in and for the County of Grant and one of the members of the County Court bench, William Johnson, of the said County of Grant and State aforesaid aged seventy-six years in the month of March next who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7th 1832. – That in the second year of the War of the revolution he volunteered under Captain William Washington in Westmoreland County Virginia for the space of twelve months and served the whole time, he does not recollect the name of the Regiment, but his Colonel was John Skinker, his Major a man by the name of Stith [possibly John Stith], his Christian name forgotten; he received his discharge but has long since lost it.

Immediately after the said term of service expired he volunteered in the company of Captain William Piper of the same County of Westmoreland Virginia, for the space of twelve months and served the whole of his time and received an Honorable discharge which has long since been lost – the said John Skinker was his Colonel, during this last service and William Stark his Major. – During the foregoing services he was stationed at and passed through the Counties of Westmoreland, King George, Richmond and Stafford, was during the foregoing time in but one engagement a British armed vessel on the waters of the Potomac in the County of Westmoreland fired on him; – was discharged from the service in Westmoreland County Virginia, he came to Kentucky about thirty-six years ago and now lives in the said County of Grant, – That he has no documentary evidence, and that he is known to no persons whose testimony he can procure who can testify to his service. – He hereby relinquishes every claim whatever to a pension or annuity except the present, and he declares that his name is not on the pension roll of the agency of any State. – Sworn to and subscribed the day and year aforesaid.

[Veteran was pensioned at the rate of \$40 per annum commencing March 4th, 1831, for service as a private for 12 months in the Virginia militia.]
