[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



I Nicholas Rhodes [sic,] aged Sixty-five years, do, upon oath, testify and declare, that, in the year 1780 – I enlisted for the term of "during the war," and served in the Regiment No. (not recollected) under the command of Colonel Henry Lee – of the Virginia line; and that I continued in the service aforesaid until the close of the war, when I was regularly discharged from the said Regiment, commanded by Colonel Henry Lee.

I further declare, that I have never received a warrant for *the Bounty Land* promised to me on the part of the United States; nor have I ever assigned or transferred my claim in any manner whatsoever: therefore,

Know all men by these presents that I, Nicholas Rhodes – aforesaid, do hereby constitute and appoint Joseph Vance – to be my true and lawful attorney, for me and in my name to demand and receive from the Secretary of War of the United States, a warrant for the quantity of Land due to me as aforesaid, and my said attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him, for the special purposes above expressed.

I Nicholas Rhoades of Miami Township Green County & State of Ohio do hereby declare that I enlisted in the Continental line of the Army of the Revolution for & during the War and continued in its service until its Termination at which period I was a private in Captain Joseph Eagleston's Company [Joseph Eggleston's] & in Colonel Henry Lee's Regiment No. not recollected of the Virginia line & I also declare that I afterwards received a Certificate for the reward of eighty dollars to which I was entitled under a Resolve of Congress passed the 15th of May 1778 – And I further declare that I was not on the 15th day of March 1828 on the pension list of the United States –

The State of Ohio personally appeared this day John Baker and William Cohagen of the said County who did severally make oath that Nicholas Rhoades by whom the foregoing declaration was subscribed is generally reputed and believed to have been a private in the Army of the Revolution in manner as therein stated. Revolutionary Claims Treasury Department, 29 January 1829

Nicholas Rhoades of __ in the County of Green in the State of Ohio has applied to the Secretary of the Treasury for the benefits of the act, entitled "An act for the relief of certain surviving officers and soldiers of the Revolution," approved the 15th of May, 1828. He states that he enlisted in the Continental line of the Army of the Revolution, for and during the war, and continued until its termination, at which period he was a Private in Captain Eagleston's Company, in Col. Lee's Legion line; and that he received a certificate for the reward of eighty dollars, provided by the resolve of the 15th of May, 1778; and further, that he was not on the 15th of May, 1828, on the pension list of the United States, and that he has received as a pensioner since the 3rd of March, 1826, __,
