[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of North Carolina County of Guilford: SS

I Adam Hart aged sixty-seven years do, upon oath testify and declare, that about or in the years 1776 or '77 I enlisted or entered the service as a Private for the term of "during the war" in the 1st Regiment commanded by Colonel Dixon [Henry Dixon a/k/a Hal Dixon], who afterwards appointed me to serve as a Waggoner, and that I continued in the service of a Waggoner aforesaid under various offices to which, first said Dixon, then Major McCree [Griffith John McRae], Colonel Thomas Donoho and last under Colonel Litle [Archibald Lytle] until the close of the war and that I continued in the service aforesaid until the close of the war, when I was regularly discharged from the said first Regiment, commanded by Colonel Lytle of the North Carolina line and when I was a Private, or Waggoner aforesaid. Colonel Lytle dismissed me from the Service at Guilford old Court House called Martinville, North Carolina at the end of the War of the Revolution, and said ["]I am busy giving discharges to those who lived a great way off you and I live near together go home now and wait a while and come to Hillsboro North Carolina and I will give you your lawful discharge["], accordingly I did so, and went to Hillsboro and found him Intoxicated, unable to do my business, I went a second time for my discharge but found he was dead.

I further declare that I have never received a warrant for the bounty land promised to me on the part of the United States; nor have I assigned or transferred my claim in any manner whatsoever.

Therefore, know all men by these presents, that I Adam Hart, aforesaid do hereby constitute and appoint Augustine H Sheppard to be my true and lawful attorney, for me and in my name to demand and receive from the Secretary of War of the United States, a warrant for the quantity of Land due to me as aforesaid; and my said attorney is hereby fully authorized and empowered to constitute and appoint one or more substitutes or attorneys under him for the special purposes above expressed.

In witness whereof I have hereunto fixed my Mark and seal this 17th day of January A.D. 1829.
