## Pension application of John China S46593 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina, Sumter District

Personally appeared in open Court on the 30<sup>th</sup> day of October 1832 the Court of General Sessions and Common Pleas now sitting for the district aforesaid John China Senior resident of Sumter District aged Sixty seven years and ten months who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7, 1832.

This deponent says that he was born on the 8 [sic] day of December 1764 in the district of Marlborough in the State aforesaid and removed to Sumter district when very young and still reside [sic] in said district and State aforesaid and this deponent further saith that he entered the Service of the United States in the State of South Carolina under General Marion's [Francis Marion's Brigade of Militia as a Soldier in September 1781 Colonel Richardson [Richard Richardson, Jr.], Colonel James [John James] and Major Gamble [Robert Gamble? or William B. Gamble?] were his regimental officers and that Captain William Dukes, Lieutenant Joseph Fox & Joseph Terry were his company officers. That he remained in said Brigade & under said officers ten months as a volunteer and in the month of August following said deponent enlisted in the State of South Carolina Service in Colonel Maham's [Hezekiah Maham's] Corps of Horse for three years under Major James Conyers & Captain James Theus and remained in said Corps until January 1783 and that on leaving the service he received no regular written discharge. This applicant further saith that he was in no general engagement but in Several Skirmishes in the State aforesaid and that the services of said applicant were performed within the State of South Carolina and this deponent doth hereby relinquish every claim whatever to a pension or annuity except the present and that his name is not on the pension [roll] of any agency of any State except the State of South Carolina.



Personally came before me John China Senior, and made oath that he served as a private Soldier in General Marion's Brigade of Militia from September 1781 to August 1782 when he enlisted in Colonel Maham's Corps of Horse, under Majors Conyers & Giles, the term of Militia Service was performed under Captain Dukes, the most of the time and served as a private in said Corps of Horse six months, The services were performed mostly through the lower part of South Carolina.

Personally appeared before me the undersigned Justice of the Peace of the District and State aforesaid John China, Senior, who being duly sworn deposeth and saith; that in September 1781 he volunteered his services as a common Soldier in General Marion's Brigade of Militia, whilst the Regiment was encamped at Doughty's plantation on Santee River. He was there placed in a company commanded by the following officers: William Dukes, Captain, Joseph Fox, 1<sup>st</sup> Lieutenant, Joseph Kerry, 2<sup>nd</sup> Lieutenant. The Regiment to which this company was attached was commanded by Colonel Richard Richardson, Lieutenant Colonel John James and Major Gamble. He served in this Regiment as a private or common Soldier ten months. He was in no Battle during this time but recollects the following engagements of the Brigade: In a month after joining the Brigade it moved from its station at Doughty's, 10 or 12 miles lower down the River to Canty's [sic, Cantey's] plantation. Whilst here this deponent was sent with a detachment of militia drafted to accompany Colonel Maham's Corps of Horse on an expedition to Haddrell's Point. He was detached from the command of his immediate company officers and does not now recollect the immediate officers in command of his company. This detachment continued out on duty eight days during which time this deponent was in a skirmish at Wapetaw [sic, Wappetaw] Meeting House<sup>2</sup> with the British who had fortified the Meeting House and encamped there. In this skirmish some of the enemy were killed and some taken prisoners. After this the detachment returned to the Brigade which from time to time changed its position up and down Santee River until December 1781 when it encamped at Strawberry Ferry on Cooper River. While it was here this deponent – with 10 or 12 others were dispatched as a guard to an officer who had in charge a cart loaded with something to be conveyed as he believes to the neighborhood of Dorchester, near this place they received intelligence that some Tories were encamped in a neighboring Bay. They repaired there and took them prisoners. In the mean time the Brigade had removed to Silk Hope bridge where this detachment rejoined them. The Brigade moved from there to a place called the Burnt Camps. From there to Wamba [sic, Wambaw Creek]. At this place, whilst Genl. Marion was absent attending the Legislative Assembly at Jacksonborough, the Brigade was surprised by the enemy and many [were] killed; among the killed was Major Benson [John Benson]<sup>3</sup> whose Corps of Horse suffered the greatest loss. After this the Brigade encamped on the North side of the river at Daniel Horry's plantation where it

remained for some time. In June 1782 after moving to different places it encamped on Pee Dee River at Birches Mill. From thence across the River to a savanna called Bowling Green in what is now called Marion District. From this place this deponent was sent on an expedition after the Tories. The detachment he thinks, but is not distinct in his recollection, was under the command of Colonel McCauley. His company was under the command of Captain Malone. Deponent thinks they were a fortnight out on this expedition and joined the Brigade lower down the Pee Dee River than the place they left it.

In July or August, the Brigade was attacked at Wadbo [sic, Wadboo] Bridge by the British who had one of their Captains of Horse killed but no one of note among the Americans was killed. The Brigade moved from this place higher up on Santee [River] where this deponent in August 1782 enlisted as a common soldier in the State Troops in Colonel Maham's Corps of Horse at that time commanded by Major James Convers, for the term of three years and under the immediate command of Captain Theus. He continued in this Corps as a private until the middle of January 1783 making a period of near six months. Two months of this time he was sick and unable to do active service but continued with the sick of the Corps. In December 1782 when the Corps to which this deponent was attached lay at Cane High Island, he obtained a furlough to spend the Christmas Holidays at home. In his absence the Corps was dismounted there being no further call for their immediate services. He rejoined them on Santee [River] but found no officers. He remained there about a fortnight and then came home about the middle of January 1783 after the British had evacuated Charleston. Making the whole time of service of this deponent a period of Sixteen months. This deponent received no written discharge and has lost his furlough.

I do hereby Certify that John China has enlisted for the term of three years and Lieut. Col. Maham State Legion he is to receive all the advantages that a Continental Dragoon is entitled to [several words too faint to discern] and to be discharged at the expiration of three years from this duty.

The Humble petition of John China Senior Sheweth

That he was a Revolutionary Soldier he entered the Service of South Carolina in the year 1781 and in the month of October he served under General Francis Marion from October 1781 to August 1782 and then was removed from the command of Marion to that of Col. Maham in his Troop and continued under the command of Col. Maham until the British Army Left Charleston [the British evacuated Charleston South Carolina in December 1782] and he further Sheweth that he received no compensation except a certificate for one month's service in the Militia only his daily rashions [rations] and that he had lived to enjoy the blessings of a free government which he would conceive ample Satisfaction, for all the fatigues & Toils of the Camp but the Senate of South Carolina in their Wisdom & Benevolence have established a pension Law by which they allow to the worn out Soldier a small pittance per annum of \$60 he further Sheweth from his annexed Schedule that he does not possess a sufficient quantity of the good things of this world to afford him and Wife the common Comforts of life and as age has advanced and time cannot remove his former Strent [strength?] but daily advancing for the worst which is the only cause on earth that would induce him to apply to his country for the necessary Assistance to afford him in his advanced days to present himself to your Honorable House with the annexed certificates and his own affidavit he hopes that your Honorable body will grant him a pension and your Humble Petitioner as in duty bound will ever pray –


