Pension application of Richard Pettigrew [Pettygrew] S46639 f20VA

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

At a Court held for Accomack County by adjournment at the Court House thereof on Tuesday the 29th day of November 1836

Leah Collins child and only heir at law of Richard Pettigrew this day personally appeared in Court and made the following declaration in order to obtain the benefit of the Act of Congress passed 7th day of June 1832 viz. State of Virginia County of Accomack SS on the 29th day of November 1836 personally came before the Justices of the Accomack Court Leah Collins daughter and only heir of Richard Pettigrew who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed 7th of June 1832. That she is the daughter of said Richard Pettigrew that she is about 40 years of age that she has frequently heard her father speak of his services on board the *Accomack* Galley in the Revolutionary War – that he resided in Accomack County until about 48 years ago when he removed to Kent County Delaware where he died on the 5th day of October 1835 – that the applicant has received a Warrant for 100 acres of Land for his Services for 3 years – that she hereby relinquishes every claim to any annuity but the present and declares that her name is not on the pension Roll of any State.

I Elkanah Andrews¹ of Accomack County hereby certify that I served on board the Galley *Accomack*² in the State Navy of Virginia in the Revolutionary War until said Galley was laid up and dismantled in 1781 and that Richard Pettigrew then living in this County also served on board said Galley *Accomack* until said Galley was laid up a period of 3 years from the time of his enlistment and upwards: that said Richard Pettigrew remained in this County a few years after the war ended and then removed to the State of Delaware & as this deponent has understood died there in the last month or two, but at what time, this deponent does not know.

Richard Pettigrew – Seaman S. Navy

This Seaman's name is on the Army register. Colonel Cropper received for him a certificate for £47.19.6 the balance of his full pay as Seaman on the 5th day of April 1785.

Elhanah Andrews, a credible witness, says that he knew Richard Pettigrew well, that he served in the revolutionary war on board the Galley *Accomac* commanded by Captain Underhill from the time it was ready for sea until she was laid up. This has in other cases been proved to be more than 3 years.

I did not find the name of Richard Pettigrew on the few pages which have been preserved relating to the *Accomac* Galley; and therefore did not report him entitled to bounty land in the printed list no. 5 of Seaman &c entitled to land for revolutionary services.

The proof is satisfactory that he was in service as Seaman, Elhanah Andrews says he served more than 3 years. The law of the land required that Seaman in the state Navy should enlist for 3 years.
