## Pension application of Moses Henry S5508 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

## State of Virginia County of Shenandoah SS

On this 9<sup>th</sup> day of October in the year 1832 personally appeared before the Court of the said County now sitting Moses Henry Senior a resident of Gooney Manor in the County aforesaid aged Seventy-seven years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the Act of Congress passed June 7<sup>th</sup> 1832. That he enlisted in the Army of the United States in the year 1776 and was attached to Captain Langdon's [Jonathan Langdon's] Company belonging to the 12<sup>th</sup> Regiment commanded by Colonel James Wood (Abraham Tipton was Lieutenant of Captain Langdon's Company). That when he enlisted he resided upon Flint River in the aforesaid County of Shenandoah. Soon after he enlisted he went to Woodstock, and marched from thence to Winchester in Frederick County from thence to a place called Camp Holly & Richmond where he joined his Regiment. That previous to his reaching the neighborhood of Richmond, he was taken sick in consequence of waiting through water and mud, and other exposures. He was so extremely ill that it was supposed by the Surgeon and other physicians that he could not recover. And he was accordingly discharged being unfit for duty in May 1777 as well as he recollects – having been in service nine months as near as he can recollect. That his discharge was given by Colonel Wood and perhaps Captain Langdon. He further states that several years ago he made application for a pension, and his original discharge was either sent in to the War Office, or has been mislaid. His former application under the former pension laws, was unsuccessful and he presumes the papers containing his former declaration are on file in the war Office. He hereby relinquishes every claim whatever to a pension or an annuity except the present, and he declares that his name is not on the pension roll of any agency in any state.

Sworn to and subscribed the day and year aforesaid.

[William Bray and Joseph S Spengler gave the standard supporting affidavit. William Bray gave a separate affidavit saying that he took the veteran's previous application along with a discharge to the war Office and recalls that the discharge, as best he recollects, was signed by Colonel Wood.

The affidavit of Abner Smith taken before the subscriber a Justice of the peace for said County on the 8<sup>th</sup> day of June 1833 – after this deponent being duly sworn he deposeth and saith

That sometime early in the year 1827 Moses Henry not being able to attend Court came before him the said Smith then an acting Magistrate of Shenandoah to make his declaration as required by law in order to be placed on the pension list under the law passed in the year 1818 and 1820 – in making out his declaration said Moses Henry presented his discharge – which was dated on the 17<sup>th</sup> day of May 1777 – and stated that he was discharged as being unfit for service and signed James Wood Commandant of the 12<sup>th</sup> Regiment and further this Affiant saith not.

John Boyd of lawful age being first sworn deposeth and saith that he had in his possession the discharge of Moses Henry in the regular service for something like the time of two years, and he further states that the discharge was signed by Wood the Commandant of the 12<sup>th</sup> Regiment and that he thinks the name of the Captain was Langdon and further this Affiant saith not.
