[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Indiana Parke County

On this 12th day of February in the year 1833 personally appeared in open Court before Joseph Batts [?] Probate Judge in and for the County of Parke and State aforesaid the same being a Court of Record now sitting David Johnson a resident of Union Township County of Parke aforesaid aged sixty-nine years four months and twenty-six days who being duly sworn according to law doth on his oath make the following Declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832. – That he entered the service of the United States under the following named Officers, and served as herein stated "to wit" that sometime in the month of May 1780 in the Western part of the State of Pennsylvania on the waters of what was called the Ten Mile Creek he volunteered under Captain John Miller Lieutenant Abel Cook, Ensign Henry Dickerson, Colonel David Williamson, they formed into a company at one John Dilley house and there we built a Block house and staid there about two weeks and then we went to a place called Lindley's Fort a distance of four miles from Dilley Blockhouse from Lindley's Fort we went to Atkinson's Fort then we scouted one to another and on what was called the waters of Wheeling and the heads of the Shirtee [?] and Sund [?]¹ in keeping stations and in scouting in all six months and five days. And in June 1781 he started with the said Captain John Miller, Ensign Henry Dickerson, Colonel David Williamson on another tour of scouting from Lindley's Fort to Atkinson's Fort and on to Wheeling Fort being in all two months in the said scouting expedition, he further says that he frequently served in common with one of his brothers under Captain Brady [?]² whenever the exigencies of the time required, and that it is impossible for him to fix dates and times in said expeditions. And he further says he was frequently employed in carrying expresses from one of the above forts to another – and he further says in June 1781 or June 1782 he volunteered in what was called Crawford's Defeat, was out in said campaign under Crawford [William Crawford] thirty-one days. He has no documentary Evidence of his services as he received no written discharges, and that he knows of no person whose testimony he can procure to testify to his service, And he made the following statements to the questions propounded to him by the Court "to wit" That he was born on the 17th day of

September 1763 in the County of Morris State of New Jersey, he has no record of his age: he was living in the Western part of the state of Pennsylvania on the waters of the Monongahela more immediately on the waters of Ten Mile Creek in what is now called Washington County when he first went into the service, he has lived since the Revolutionary [war] in the State of Ohio and from there to the State of Indiana where he now resides, he cannot state the names of any other officers as there was none other than those mentioned by him in the tour of spying in which he was engaged, nor can he state any other circumstances of his services than those stated above, a great many facts have long since been obliterated from his memory, he states that the persons names to whom he is known in his neighborhood are Charles Newgent, Laban Ellis, and who can testify as to his character for veracity, and their belief of his services as a Soldier of the Revolution. He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State that he knows of.
