[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina Darlington District

On this the 25 day of March A.D. 1834 personally appeared in open Court and the Court of Common Pleas for the District and State aforesaid Albert Fort, a resident of the same State and District aged Seventy-six years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832. That he was born near the town of Tarborough on Tar River North Carolina on the first day of April 1758: that his age was recorded in a Testament which deponent believes at this time to be lost. When he was about eight years old his father removed with him to Kershaw District South Carolina where he lived ten years and then moved to Darlington District where deponent has lived ever since. He was living in Kershaw District when he entered the service as a substitute for his father under Capt. John Chestnut of the Militia. He went from Kershaw to Purrysburg on the Savannah [River] -- he marched in a Regiment commanded by Col. Joseph Kershaw, which Regiment was stationed at Purrysburg where deponent remained until his term of three months expired. He had no engagement with the British, but could hear their evening & morning guns at Savannah where they were stationed. Deponent cannot fix the precise time of his service, but knows it was immediately after the capture of Savannah by the British. In the year 1779 he served three months as a private in the Militia under the same Capt. -- was drafted & marched to a small town on the Georgia side of the Savannah River where he remained until the expiration of the time for which he was drafted. In the year 1781 he served one month as a drafted militia man in General Marion's [Francis Marion's] Army on the High Hills of Santee and Lieut, Boykin's Company (that he is in the Company which he commanded). Also in the latter part of the year 1782, he served one month at Jeffries Creek Bridge in Darlington District under Capt. Connel [Simon Connell] Col. Baxter [Jacob Baxter] being the highest Officer. He was stationed at this place & remained there during the whole time except when occasionally sent out on excursions against the Tories in the neighborhood. He has just stated specifically all those terms of engagement upon which his memory can't fix with sufficient certainty. He well knows however that he served during the whole of the war whenever he was called upon which was much oftener than he has enumerated: but not being able to specify those terms particularly so as to meet the requisitions of the Department he makes no claim for any Services other than those already mentioned. He has just stated as well as an imperfect memory will allow the general circumstances of his Service -- he recollects no other names of officers than those he has mentioned & he threw away or lost every discharge which he ever received. Those who received

from the Officers under whom he served, at the expiration of each term he engaged, so that he has no documentary evidence of his services & knows of no person now alive whose testimony he can procure, who can testify to his service. He hereby relinquishes all claim whatever to a pension or annuity except the present & declares that his name is not on the Pension Roll of the Agency of any State.
