Pension application of Solomon Good S6897 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Burke County: Court of Pleas & Quarter Sessions October Term 1832

On this 24th day of October personally appeared in open Court before the Justices of said Court now sitting Solomon Good Senior a resident of said County, and State aged 72 years knows himself to be that old from a record made by his Father which he has often seen, who being duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act passed by Congress of the 7th day of June 1832.

That he entered the service of the US under the following officers and served as herein stated (viz.) That at the time he entered the service he lived in Halifax County North Carolina where he enlisted for a term of six months under Captain William Alston Commanded by Colonel Nicholas Long that I entered the service some time in the month of March 1776, the day of the month I am unable to say that on my first entrance in the Army I immediately marched from Halifax Town under command of Captain Alston down below Neuse River in Onslow County for the purpose of joining General Caswell [Richard Caswell] that before we marched General Caswell and the Army under his command, we were informed that General Caswell had just had an engagement with the Scotch and the old Regulators as they were then called and succeeded in overcoming them. That himself and company returned to Halifax Town where he remained the balance of the six months for which time he had enlisted, in guarding the prisoners to the (Scotch and Old Regulators) where they were committed after being taken. That at another time I was ordered into service in the County of Orange State North Carolina where I then resided some time in the year 1781. That I was engaged in the regular service for the term of three months in guarding the Town of Hillsborough in said County from the attacks of the Tories and guarding the Jail in order to prevent the escape of the prisoners which were constantly committed. That I was there under command of Captain Jameson [William Jamieson] and Colonel Taylor [Lieutenant Colonel Thomas Farmer] of Orange. After this Service I was repeatedly called into Service which was principally confined to the Counties of Orange and Halifax a few weeks &c at a time. My services are entitled [?]² to something like 11 months part of which time I was a substitute for man by the name of Smith. I was regularly in the service 9 months perhaps rather more.

I hereby relinquish every Claim to a pension or annuity except the present and do hereby declare that my name is not on the Pension Roll of any State or the agency of any State.

State of North Carolina, Burke County

I Henry Woods of the County and State aforesaid do hereby certify that I am acquainted [with] Solomon Good Senior now of the County of aforesaid that I knew him during the Revolutionary War, that sometime in the year 1781 he knew him to be engaged in military services for the support of the United States in Hillsboro Orange County where he then resided – That he was under Command of Captain Jameson where he remained for the tour of three months guarding and protecting the place against the invasions of the British and Tories.

Sworn to and subscribed in open Court this 24th day of October 1832.
