## Pension application of Robert Horn S7023 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of North Carolina Iredell County: Court of Pleas and Quarter Sessions November Term 1832

On this 21st day of November personally appeared in open Court before a Court of Record now sitting Robert Horne [sic] -- a Resident of Iredell-Rowan County State of North Carolina aged seventy-two years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated: that he entered the service of Captain James Shepherd of Surry County North Carolina, Colonel Locke [Francis Locke] commanded the Regiment and Griffith Rutherford was the General: that he went from Salisbury Surry to Salisbury being drafted, and thence through Charlotte to Camden in South Carolina and thence to Dorchester same State; then to Puvisville [sic, Purrysburg] on Savannah River and then he volunteered for two days and stayed two months under Captain Shepherd, under Colonel Lytle [Archibald Lytle] Continental Officer & Continental Major Nelson -- that he then marched up Savannah River to Augusta, the American Army being on one side of the River and the British Army on the other, skirmishing almost every night during which time he saw the British General Provost or Provo [sic, Augustin Prevost] buried [?] on the opposite side of the River which was in the year (1789)[ sic 1779] -on Saturday the British started down the River, and the American Army crossed over on Tuesday into Augusta, and followed the British Army to Brier Creek, joined General Ashe's Army and on the 3rd of March a battle took place Deponent was in front, and with the others was defeated after fighting from 3 o'clock until dark as they were followed into the lagoons and swamps from which they fought and in which many of our men were drowned. He then joined again General Rutherford getting back over the River as well [as] one was able; returned to the old camps at Purrysburg and was there discharged and returned home -- Deponent in the foregoing service had been drafted for 5 months but from urgent circumstances served 6 months.

In the year 1780 he was drafted for 3 months under Captain Henry Speer, Philips was Colonel, marched to Salisbury, there stayed some time guarding the prisoners taken by Colonel Morgan at the battle of the Cowpens, <sup>1</sup> and with the prisoners marched into Virginia and gave them up to the Virginia troops, being pursued by Cornwallis; Colonel Leneer was the officer to whom we gave up the prisoners, and then he returned home, having received a discharge from the Captain which with the first discharged believing them to be of no use have been mislaid or

lost -- The 3rd time he was drafted for 3 months and 1781 in Surry County, served under Captain David Humphries, and Lieutenant Benjamin Humphries, and another brother who was Ensign, marched to Salem North Carolina; thence to the Raft Swamp in said State, and thence to Wilmington, was in several skirmishes and one night killed eighteen of the enemy. The field officers were General Rutherford Colonel James Martin, Majors Baisley [Paisley?] & Gillespie, was dismissed at stony-point and on the bank of Cape Fear River rejoiced at the news of Cornwallis's being taken and was one appointed to fire volleys for the thirteen United States -- This discharge was lost for the reasons above. Deponent also served one month in the Company of the Rangers one month under Captain David Caldwell.

How were you called into service? Ans. I was drafted

To whom are you have known in your Present neighborhood? To John Angel Preacher in the Baptist Church whose certificate is here with enclosed -- This Deponent relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State.

State of North Carolina Surry County: This day came Carter Hudspeth<sup>2</sup> before me Josiah Cowles a Justice of the Peace in and for said County and made oath in due form of law that he was in the Army of the Revolution in the company of James Shepherd & that he performed the tour to Purrysburg under General Rutherford of the North Carolina Militia & that Robert Horn was a soldier in the same company & performed his service faithfully and returned home with me and further that the Robert Horn above making declaration for a pension is the same person.

Sworn to and subscribed this 23rd day of August 1832.

[Veteran was pensioned at the rate of \$43.33 per annum commencing March 4th, 1831, for 13 months service as a private in the North Carolina militia.]
