Pension application of Richard Jordan S7087 Transcribed by Will Graves f16NC 11/11/08: rev'd 3/16/16

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Pitt County: SS

On the ninth day of August 1832 appeared in open Court before the Justices of the Court of Pleas & Quarter Sessions for the State and County aforesaid now sitting Richard Jordan a resident of Pitt County and State of North Carolina aged ___ years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

He states he was born in Surry County in the State of Virginia that he has no record of his age but believes he is seventy-two or three years of age, that he was living in the County of Pitt in State of North Carolina when called into service, that since the Revolutionary War he has resided partly in Pitt County and State aforesaid and a part of his time in Anson County in the same State: that at present he resides in the County of Pitt and State of North Carolina: that he was drafted and served the space of five months in the militia under General Bryan [William Bryan]¹ and General Ashe [John Ashe] and that William Caswell was the Colonel of the Regiment in which he served and that in this tour of service he was with the Army at Briar Creek [March 3, 1779]² in the State of Georgia and that he was discharged from the Service by Major Redden Blount [Reading (Redding) Blount]³ that he left his discharge with his mother on his return and does not know what has become of it since: that Nathaniel Cannon was the Captain under whom he was drafted.

And the said Richard Jordan further states that subsequently he served as a Substitute for his brother-in-law Burwell Edwards of Edgecombe County & State of North Carolina for the space of three months under Captain Batts [John Batts] and Colonel John Sheppard, that he was marched to Charleston in the State of South Carolina where General Lincoln [Benjamin Lincoln] commanded and there received a discharge, a few days before the surrender of the town [Charleston South Carolina was surrendered to the British on May 12, 1780], ⁴ from Captain Batts. And the said Richard Jordan further states that he served another tour of three months in the Cavalry as a Substitute for Jacob Tison [Tyson?] under a General Marquis [Lafayette] as he

believes, by whom he was marched from Tarboro in Edgecombe County North Carolina to Granville County in the same State where they joined General Caswell and that he there lost his horse which caused him to be placed under a Captain Richards [James Richards] of the Infantry by whom he was discharged at the expiration of this tour -- that he left said discharge with his mother and does not know what has become of it. In the said Richard Jordan further says that subsequently he served another tour of three months as a Substitute for Burwell Edwards -- the same Burwell Edwards aforementioned of Edgecombe County in State of North Carolina -- that he does not recollect the names of any of the Officers, but was marched towards Wilmington North Carolina where the British & Tories were doing great damage by plundering and burning -- that he received his discharge and returned home to Pitt County, North Carolina -- just before the battle at Moore's Creek [February 27, 1776]. He further states in addition to the foregoing he served several short tours in pursuit of the Tories but cannot give any strict account of the number of days except in one instance a service of 20 days while Crag [sic, James Craig] and the Tories were burning and destroying on Neuse River above New Bern & that he was with General Bryan when his house was burnt which was during this service -- that he has no documentary evidence and that he knows of no person whose testimony he can procure who can testify to his service. That he is known to John Joiner Esqr. and Sherwood Tison Esqr. who reside in his neighborhood and who can testify as to his character for veracity and their belief of his services as a Soldier of the Revolution.

And the said Richard Jordan hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the Pension Roll of the Agency of any State.

[Veteran was pensioned at the rate of \$49.16 per annum commencing March 4th, 1831, for 14 months as a private in the North Carolina Infantry & Cavalry, both in the militia service.]
