Pension application of Smith Mason S7180 Transcribed by Will Graves f18VA 3/13/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Virginia County of Caroline: SS

On this 12th day of November 1832 personally appeared before the Justices of the County Court of Caroline and State of Virginia Smith Mason a resident of and in the County of Caroline aged sixty-nine years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832.

That he entered the service of the United States and served as herein stated. He was drafted in the Virginia militia at Caroline Court House in March 1779 under Captain James Johnston, He marched to Williamsburg through Hanover [County], and the James River Counties, under Colonel Anthony Thornton, where he was put under the command of Governor Henry [Patrick Henry], and there served as a Guard to Capital and College Landings. He served his whole Tour there being two months. – In his next Tour he was drafted in the latter part of October in the year 1779 under Captain John Tyler (George Tyler being Lieutenant) marched to Williamsburg, and went as far as New Kent Court House, was there countermanded and sent back to port Royal, stayed there two months.

In the third Tour he was in the service three months. He was drafted in the County of Caroline under Captain James Sutton, marched down below Richmond, to the Morven Hills [Malvern Hills]. He then went up to Culpeper [County] to joined the Marquis Lafayette whom he joined at the Raccoon Ford, returned to Bottoms Bridge and was there discharged –

In his fourth and last Tour he was drafted at and marched from Caroline Court House under Captain John Tyler and marched down to the Siege of York, he was stationed on the Gloucester side of the River, and remained there during the Siege after which he marched to Fredericksburg and was there regularly discharged. He was here in this tour two months – He was born on the 20th of March 1763. The register of his age is in his family Bible. He has no Revolutionary Papers and has always lived in the County of Caroline. By reason of old age and consequent loss of memory he cannot be more particular or definite in his declaration. He has no other testimony than that of his Brother Benjamin Mason aged 67 which is hereto annexed. He hereby relinquishes every claim whatever to a pension or an annuity except the present and declares that his name is not on the Pension roll of the Agency of any State. Caroline County State of Virginia: Sct.

I Benjamin Mason aged 67 years being first duly sworn do hereby declare that the several tours and services up Smith of Mason my brother are true I having lived in the house with him and well recollecting his marches and tours as set forth in the annexed declaration. In the last tour he sets forth, I was with him as a militia man. Given under my hand this 12 November 1832 S/ Benjamin Mason

[Veteran was pensioned at the rate of \$20 per annum commencing March 4th, 1831, for service as a private for 6 months in the Virginia militia.]
