Pension application of John McLaughlin S7212 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Rowan County

On this 19th day of November 1832 personally appeared in open Court before the Magistrates who are Judges of the Court of Pleas and Quarter Sessions now sitting for Rowan County; the same being a Court of record, John McLaughlin a resident of said County aged Seventy-nine years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832.

That he has a record of his age at home in an old family Bible which states that he was born the 23rd day of March 1753 in Bucks County Pennsylvania.

That he first entered the service of the United States in Bucks County aforesaid in the company of Capt. Patterson as a volunteer and went to Amboy where he was stationed three months Col. Erwin being the chief officer there, in 1776. That he was afterwards a volunteer in Capt. Patterson's Company and marched to Coryls Ferry [sic, Coryell's Ferry] on the Delaware [River] and was stationed there for some time, does not recollect how long, but thinks two months; no other troops were there beside Capt. Patterson's Company, our business there was to guard some Boats then in the River at that place the boats were ordered to be removed up the River & Capt. Patterson's company dismissed for that time.

That he was afterwards a volunteer in Capt. Patterson's company and marched to Trenton and was stationed near that place for three months; does not recollect any of the Superior officers except General Washington, that he was present when 900 Hessians were captured at Trenton [December 26, 1776], recollects that 2 or 3 of the Hessian prisoners hanged themselves and several others drowned themselves in the River as it was then said to escape being murdered by the captors in the year 1776.

That shortly afterwards he was again a volunteer in the Capt. Patterson's company and was stationed at Trenton three months during which time he marched to and was at the Battle of Princeton under General Washington in the year 1777. That he knows of no person whose testimony he can procure that knows anything of the above stated services.

He removed in the month of September or October 1778 to Rowan County North Carolina where he has resided ever since.

That in 1780 he volunteered in Rowan County as a Light horseman in the troop of Col. Marlberry [Francis de Malmedy, Marquis of Bretagne], (a Frenchman) John Rowan Major are the only officers he now recollects and was stationed at the town Creek near Camden South Carolina while General Greene's [Nathanael Greene's] camp was at the High Hills of Santee about 20 miles distant he volunteered for three months but does not recollect whether he served the whole time or not, but believes he was on duty at least two months.

That he again volunteered for 3 months as a Light horseman in Capt. Samuel Hearts [Samuel Hart's] company under Col. Dickson [Maj. Joseph Dickson] and marched to the neighborhood of Charlotte North Carolina where some of the British troops were then stationed, he was there accidentally wounded in the back by the bayonet of another Soldier and was carried home a distance of about 40 miles -- after he recovered of the wound he returned back to the camp near Charlotte & served out the balance of the three months.

Besides these several tours of service he was frequently out as a soldier for a few days at a time making altogether as he thinks two months during which times he was at the Battle of Ramsour's Mill [June 20, 1780] in Lincoln County North Carolina and at a skirmish with the Tories at Callsons [Colson's Mill, July 21, 1780] on Rocky River.

He states that age and infirmity have much impaired his memory so that he is unable to name any other officers of the Army with certainty. He further states that in all the service after he removed to North Carolina he furnished his own Horse -- That he has no written discharge nor does he recollect ever having received any -- owing as he supposes to his always being a volunteer. No clergyman living in a reasonable distance he is unable to procure the certificate of any one acquainted with him. He hereby relinquishes every claim whatsoever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State having never applied for a pension before.
