Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Wake County

Personally appeared before me the, James M. Terrell one of the Justices of the Court of Pleas and Quarter Sessions of the County aforesaid duly commissioned and sworn and residing in said County, to wit, John Pierce, an aged citizen of said County of respectable character and standing on this the Twenty first day of June, in the year 1844, and made the following Declaration before me, on oath, to entitle himself to the benefit of the Act of Congress made to provide Pensions for the Soldiers of the Revolution: that is to say: that his name is John Pierce; that he is now aged eighty-two years; that he resides in the County aforesaid; that he resided there at the time he entered the Army of the Revolution, and has continued to reside in said County ever since his discharge from the said service: that he was a soldier in the war of the Revolution, as a private in the Infantry Company commanded by Captain Lane [Martin Lane and Robert Lane, both captains in the Wake County regiment of militia were at Eutaw Springs], in the North Carolina line of the Continental Army, under the command of General Green [sic Nathanael Greene]: that, as such, he was in the Battle at Eutaw Springs [September 8, 1781], and was stationed at the High Hills of Santee in South Carolina at the time of the surrender of Cornwallis [Yorktown, October 19, 1781] -- at Little York -- soon after which he was discharged from the service and returned home: that his present great age and impaired memory, puts it out of his power to state precisely the date of his entrance into the said Army or the date of his discharge from the service, but to the best of his recollection and belief he served part of the years 1780 and 81 but that he will submit such other testimony of his service as a soldier in that war, as he can now procure which taken in connection with his own Declaration, as aforesaid, will, he is advised & believes, entitle him to a Pension: that he has never been put on the Pension Roll, and never applied for a pension until now and for the reason, that he never knew until lately that the Government of his Country had provided such relief for the Soldiers of the War of the Revolution: that he now relinquishes all right to a Pension, whatever, unless he can claimant under the Act of Congress of June 1832: and lastly, that his great age & infirmities put it out of his power to attend Court to make his Declaration aforesaid, and therefore can only make it before a single Justice at or near his own home in the vacation of said Court.
