Pension application of Henry Bedinger¹ S8059 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[State of Virginia, Jefferson County]

For the purpose of obtaining the benefit of an act entitled "An Act for the relief of certain Surviving Officers and Soldiers of the Army of the Revolution" approved on the 15th day of May 1828 – I, Henry Bedinger of the County of Berkeley in the State of Virginia, do hereby declare, that I was an Officer of the Continental line of the Army of the Revolution and served as such in the end of the war, at which period I was a Captain in the fifth Regiment of the Virginia line – And I do also declare that I afterwards received certificates (commonly called commution [commutation] Certificates) for a sum equal to the Amount of five years full pay, which sum was offered by the resolve of the 22nd of March 1783 instead of half pay for life, to which I was entitled under the resolve of the 25th October 1780 – Witness my hand this 3rd day of June 1828.

State of Virginia Jefferson County: SS

Be it known before me James Grantham a Justice of the Peace for the County and State aforesaid, personally appeared Brayton Davenport of said County and made oath in due form of law that he is the Executor of Henry Bedinger, the identical person who was a pensioner, and who is now dead, and to whom a certificate of pension was issued under the act of Congress of the 15th May 1828 for a pension of \$480 per annum as a Captain in the 5th Regiment, Virginia line of the revolution. That the deceased pensioner resided in the County of Jefferson in the State of Virginia for the space of about two years and two months before his death and that previous thereto he resided in the County of Berkeley and the State of Virginia. That the said Henry Bedinger died in the County of Jefferson and State aforesaid on the 14th day of May 1843 having first duly made and published his last will and testament. The said Henry Bedinger left no widow, but the following children, Mrs. Nancy Swearingen, who was Nancy Bedinger and Mrs. Elizabeth Davenport wife of the affiant. The said Brayton Davenport states that he has been informed the said Henry Bedinger was a quartermaster as well as a Captain, holding both offices at the same time, as the affiant has been informed and in the allowance of pension of \$480 under the Act of Congress of 15th May 1828 no estimate was made of the services of said Henry Bedinger as quartermaster which the Affiant is informed should have been

taken into consideration if the fact had been known to the Department he refers to the public records and materially to the extracts from those of the State of Virginia which will accompany this application now made for the balance of pension so do you and unpaid to the said Henry Bedinger from the 4th of March 1826 to the day of his death that is to the 14th day of May 1843

[Veteran was 1st pensioned at the rate of \$840 per annum under the act of May 15, 1828. Veteran was pensioned at the rate of \$512.50 per annum commencing March 4th, 1831 for 19 months service as a Captain and 5 months service as quartermaster in the Virginia Continental line.]
