Pension application of Joseph Campen S8171 Transcribed by Will Graves f11NC 11/2/10: rev'd 12/14/16

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina County of Beaufort: August Term 1832

On this 22nd day of August 1832, personally appeared in open Court, before the Worshipful the Court of Pleas & Quarter Sessions of the County of Beaufort now sitting Joseph Campen Senior a resident of said County, aged seventy-eight years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named officers & served as herein stated: That in say – Soon after the commencement of the Revolutionary War, he volunteered as a militia man, in the said County in the State Troops, but does not recollect the date of his so entering the service, but the period of his engagement was for three months – that he served out the said tour and was principally employed with his Associates in arms in watching the movements of the Enemy & of the Tories, near & along the Virginia line – that was in no Battle during his said period of service. That after his discharge he was twice drafted and both times hired substitutes to go in his room. After the this & near the close of the war, he again volunteered in said County as a militia man, in the State Troops, in the company commanded by Captain Leith, and to the best of his present recollection his Regiment was commanded by Colonel Brown & Major Dennis – that he does not recollect precisely the date of his entrance at this latter time into the service but it was early in the fall of the year and was a part of the force put in requisition to intercept Cornwallis in his then expected march through this State: that he was in no Battle, but was marched to the Pedee River, where we expected to meet with Cornwallis & General Green [sic, Nathanael Greene], and after remaining there a few days we were marched to Dan River where we joined General Greene & afforded him succor, thence we were marched to Cross Creek expecting to meet a force of the enemy, who it was said had invaded the State in that vicinity – thence we were marched to Kinston in this state – where this affiant was discharged by Major Dennis & late in the month of March the period for which he volunteered when he entered the service at this latter engagement was three months, but he yielded to the emergency of the circumstances in which the Country was placed & consented to be detained & served upwards of six months before he got his discharge. Soon after his discharge & he reached home, news of the capture of Cornwallis was received. He, at this late date, has no documentary evidence of his entrance into the Army, nor of his discharges there from, having lost them many years since, nor does he know of any individual now living by whom he could prove his services as aforesaid. He is now an old man, past labor & is poor & has a family to support.

He hereby relinquishes every claim whatever to a pension or annuity, except the present, and declares that his name is not on the pension roll of the agency of any State, except that of the State of North Carolina.
