[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

That the said Clements served at various times when called out as much as three or perhaps four years. The said comments was present when the Army was disbanded by General Marion. That when in the service the said Clements was laboring under two severe wounds, one on the head and one on the hand, marks of which are on his person to this day, which he received from some daring Tories a few days before he was called out.

Declaration of Clement Clements

South Carolina

Lexington District SS

On this Eighth day of April in the year of our Lord 1844 –

Personally appeared in open Court before the Honorable John B O'Neal – Clem Clemments [sic] a resident in Lexington District age 79 or 80 years who being duly sworn according to Law doth on his Oath make the following declaration in order to obtain the benefit of an Act of Congress of the United States passed June 7th 1832.

That he was born in Bedford County Virginia where his Father then lived who removed to South Carolina and Settled in Darlington District when this declarant was Seven years old where he resided when the war of the Revolution Commenced and during its continuance youth as he was turned out volunteer in a Company commanded by Captain Peter Dubose and marched to Santee [River] and there stationed twelve months General Marion [Francis Marion] Commanding the forces encamped near the Plantation of Colonel Horry during which time was sent out with a force & captured a Tory encampment on little Pee Dee [Pedee River] commanded by Burnt foot Brown [Thomas "Burnt Foot" Brown] as the Captain of said Tories and our forces commanded by Major Zimmerman Captain Ellison of Infantry & Captain McCally of the Light Horse; Shortly after moved to Wadboo near Moncks Corner across the River and soon sent to Haddrell's Point where a body of British & Tories were embodied commanded by Colonel Fanning [David Fanning], and a smart skirmish ensued and took them, their Colonel though

made his escape from us. We were commanded on that occasion by Colonel Lemuel Benton & Captain Dubose, returned to Wadboo often moving about without any particular skirmishing for a space of time. –

Declarant saith from his weight of years and defective memory remembers not the dates of his particular services in the particular terms, so as to fix months & years &c But his 1st tour was in

July at Mars Bluff 2 months November at do 2 months January at Ports ferry 2 months at Santee 2 months Decr. at Wapmasaw 2 months Apl. at Four Holes 2 months Augt. at Biggin Ck 2 months January at do & Wadboo 2 months 12." add first two years & 8 months, 2 y 8 months

while at Wadboo the war ended, was discharged and went home young [?] during his services in the encampments was commanded by Captain Dubose Major Zimmerman under General Marion and when about Home was much of his time Scouting parties after the Tories under Command of his Brother Gabriel Clements who was Captain of the Scouts about the Community so yielding to the calls was nearly on constant duty service & fatigue until the final close of the war.

Declarant saith in the Battle at Eutaw Springs [September 8, 1781], he received a severe wound from the enemy's Sword on his head & hand, and before was taken prisoner by the Tories and abused and slightly wounded by their goading or Jabbing their Sword in his legs & other parts of his body when he escaped from them [paper torn and text missing] boy he was [indecipherable word]⁴ into the Services above detailed without any other material wounds in all the war.

Deponent saith that he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency except the state of South Carolina.

The State of Georgia Marion County: Know all men by these Presents that I Clement Clements of Marion County in said State, Revolutionary Soldier, formerly of Lexington District in the State of South Carolina having moved away from the said District in the year 1847 and previous thereto presented my claim to a pension from the United States under the Act 7th June 1832 and which was suspended for further material evidence – I also being now & having been for many years, a pensioner of the State of South Carolina, do Constitute, make and appoint James A. Black Esquire Attorney at Law, Columbia South Carolina my true and Lawful attorney for me



and in my name and place and stead to prosecute my said claim before the Pension Office at Washington to final Settlement, to offer such new and material evidence as may secure the allowance of the said Claim with power also and Attorney or Attorneys under him for that purpose to make and Substitute and to do all lawful acts for effecting the Premises, hereby ratifying and confirming all that my said Attorney or his Substitutes or Substitute shall do therein by virtue thereof. In witness whereof I have hereunto set my hand and seal this 8th day of November in the year of our Lord 1851

The Humble Petition of Clement Clement [sic]

Sheweth

Unto your Honorable Body that he was a Soldier during the Revolution, and Served in the Regiment of Colonel Lemuel Belton [sic, Lemuel Benton], under Captain Andrew Dubois [Andrew Dubose], Commanded by General Marion [Francis Marion] from the year 1780 to 1782. That he never has been paid for said services. That he is very poor, and obliged to support his wife and four of his children that are yet very young by his personal labour; which has now become very arduous & painful, from the debility of age necessity attendant on old age

Therefore your Petitioner prays your Honorable body to give him such compensation for his said services, as to them may seem meet, and therefore relieve the wants and infirmities of old age and poverty.

The Humble petition of Clement Clements Sheweth that he served in the State as a volunteer in the Revolutionary War as follows. Viz. – that he joined the 18th Regiment as a volunteer in the year 1780, under the command of Colonel Lemuel Benton in the company commanded by Captain Andrew Debush [sic] & under the command of General Marion, & that he always behaved as a good Soldier & a volunteer for the space of three years, & that he was wounded in head & hand very severely in a Scrimmage with a party of the Enemy in Darlington District in the year 1781 & that he was also wounded in the Leg at the Battle of the hanging Rock above Camden.

Your petitioner therefore humbly Submits that he is in justice to himself, & the State of South Carolina, entitled to his Arrearage of Pension from the year 1816, to 20 [? sic] for his said Services, & the Wounds he received in the defense of his Country; for Reference of said Services I would beg leave to refer you to the Clerk of the Senate, & the Comptroller General Books, where you will find that I was placed on the Pension List at your last Session but the Pension Act taking place in the year 1816, which justly entitles your petitioner to the four years pension which he petitions your Honorable House to grant him & therefore begs your Honorable Body to take his case into Consideration & grant such relief as his just [text obliterated by ink blot] 2nd December 1822 S/ Clement Clements, X his mark The petitioner's application was in 1820, supposes himself to be entitled from 1816, This

Committee thanks him not entitled to Pension before he applied, therefore Rejected
