Pension application of William Cooper S8250 Transcribed by Will Graves 12/6/10: rev'd 12/1/19

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina Pitt County: A.D. 1832

On this sixth day of November personally appeared in open court before the Justices of the Court now sitting William Cooper of Pitt County North Carolina aged sixty-nine years and eight months, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th A.D. 1832.

That he entered the service as a volunteer under Godfrey Stancil Captain, Abram Hardy Lieutenant and Henry Moore Ensign, having enlisted for three months about the close of the revolutionary War, and served out the whole period for which he enlisted. He was born and resided in Pitt County North Carolina at that time as he does now and his company formed at Greenville the County town – marched to Nash County (North Carolina) Court-House and there joined the Regiment commanded by Colonel Herritage [John Herritage] and Lieutenant Colonel Nixon [Richard Nixon]. General William Caswell was with the militia embodied at Kingston [sic, Kinston] (North Carolina) and was also the General officer of the Regiment at Nash Court-House – from Nash Court-House he marched to Harrisburg Virginia where the Captain's Company to which he belonged were selected to conduct Colonels Culp and Wade (two civilians of Georgia who, when Cornwallis was ravaging the southern Country, had fled their homes with their movable property and now wished to return) to Georgia; of which service he marched as far as the Pedee about Cheraw (South Carolina) where his company was attacked at night and defeated by the Scotch Tories residing in that section. The whole company was disbursed and returned home to recruit - then he repaired according to orders to Kingston North Carolina and was employed for the balance of the term on the Scouting service about Neuse River. The term expired, he returned home and staid about one week, when he enlisted again for three months – repaired to Greenville again under Captain George Fortner, Lieutenant Evan Jones and Colonel James Gorham and was off and on at Greenville and Kingston with his company waiting orders from General Greene who was pursuing Cornwallis through the up country which orders however never arrived. He stayed with his company at the aforesaid places until the war was closed by the surrender of Cornwallis at Yorktown, upon which event he was discharged just three days before his term expired – thus serving six months altogether lacking three days. As the term expired not by his own act, he submits whether he should not be considered and paid as having served six months entire. His discharge he has lost.

He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of any state or agency whatever. Sworn and subscribed the day and year aforesaid.

State of North Carolina Pitt County: SS

On this 5th day of September 1833 personally appeared William Cooper before the Judge of the Superior Court of Law at the court held for the aforesaid County at its Session. The said William Cooper being a resident in the County and State aforesaid, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832:

That he enlisted as a volunteer in the Army of the State aforesaid under General Caswell in Captain George Falconer's Company. That the said company left Greenville in the said State and County, and marched to Harrisburg Virginia, in order to get in company with General Butler, that they marched from Harrisburg towards Pedee South Carolina. That Captain Falconer's Company and Captain Stansill's Company was here sent from General Caswell's Army to Guard the magazine at Coulson's ferry, but were routed by the Tories and dispersed before reaching there, that the to said companies came back to Greenville and there joined General Levington's [sic, Lillington's?] Regiment – and marched to a place near Wilmington, that after remaining a short time at this place the two said companies were dismissed and returned home. That this service was during the last of the revolutionary war but he does not recollect distinctly the date. That he distinctly recollects that he served six months and seven days including the time it took him to get to Greenville where he was dismissed by Colonel Gorham.

That he was born in Martin County in the State aforesaid in the year 1763. That he had a record of his age till about seven years past when it was destroyed. – That he was living in the County of Pitt when he became a volunteer and entered into service. That to the best of his recollection he was about 13 years of age when he became a resident of this County where he has ever since lived.

He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the pension Roll of any agency in any State.
