### State of North Carolina County of Rowan

On this 18th day of August 1835 Personally appeared in open Court before the Justices of the Court of Common Pleas and Quarter Sessions who are the presiding Judges of said Court now sitting Jacob Deal a resident of said County and State aged seventy-three years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832. -- That he entered the services of the United States under the following named officers and served as herein stated: That he was first called into the service as a substitute for his father in Mecklenburg County North Carolina who was drafted in the militia in the fall of the year 1779. That they assembled at Phifer's Red Hill in Mecklenburg now Cabarrus County and under Capt. Richard Graham or Grimes marched to Charlotte where they joined the Battalion under the command of Col. Lillington and marched from thence by Camden to Charleston and was somewhere about 15 days at Fort Moultrie on Sullivan's Island where there was some shooting between the Fort and American ships with the British fleet, his time being nearly expired he was brought back to Charlotte & shortly afterwards discharged upon the arrival of other Militia in Charleston who were taken prisoners when the city was captured -- the time of his service at this expedition was three months.

Soon after his return from this first trip, he was drafted in the militia in Mecklenburg County at Phifer's as aforesaid and marched from thence under the command of Capt. Fulenwidor [Henry Fullenwiden?] to Rocky River -- where General Davidson [William Lee Davidson] was commander, and where Col. Washington's cavalry were stationed for some time, & Col. Dickson's [probably Henry Dixon's] troops of the Regular Army -- while the British troops were at Charlotte after the British retreated from Charlotte the militia came to camp near that place where, their time expired and he was discharged after having served three months –

In the summer of the year 1781 he was again drafted in the militia under Capt. Criminger<sup>1</sup> and marched to little River where they joined General Rutherford's troops and marched from thence to Wilmington & was there at the time they heard the news of the capture of Cornwallis at Yorktown and was discharged at the end of three months, the whole time of his service as a private soldier Dean nine months --

That he was born in North Hampton County Pennsylvania in the year 1762 as his record at home now shows -- that at the age of about 12 years he removed to Mecklenburg County NC and in a few months after removed to Rowan County where he has resided ever since. That he never received any written discharge but once -- and that being sent to the war department it has been there considered as issued in the name of some other person. He further declares that no

clergyman acquainted with him this in any reasonable distance and that he cannot procure the certificate of any. He refers to the certificate of his neighbors Henry Stinewalt and Jacob Shuping who are acquainted with him and can testify as to his reputation and veracity. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll of the agency of any State.

Krimminger and Graham and who draws a pension of \$30 per annum for his services in the revolution. Petition is signed S/ Jacob Deal, X his mark.]

State of North Carolina Rowan County: I hereby certify that on the 11th day of November 1834 personally appeared before Adam Roseman a Justice of the peace in and for said County Philip Miller aged about 75 years who says upon oath that he is well acquainted with Jacob Deal of Rowan County who was a Soldier in the war of the Revolution in the Militia and marched from Yadkin River on to Wilmington a private in Capt. Frederick Gremminger's Company and that the term of militia service at that time was three months.

R. Grimes Company and that the term of military service at that time was three months.

State of North Carolina Rowan County I hereby certify that on the 10th day of November 1834 personally appeared before Adam Roseman a Justice of the peace in and for said County Frederick Stigerwaldl<sup>4</sup> aged about 72 years who says upon oath that he is well acquainted with Jacob Deal of Rowan County who was a soldier in the war of the Revolution in the Militia and marched from Phifer's Read Hill to Rocky River then on to Sugar Creek then to 10 mile Branch a private in Capt. Henry fulwiter Company and that the tour of Militia service at that time was three months.
