Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." On this 7th day of December 1821 before me the subcriber, a Justice of the peace for the said county of Mecklenburg personally appeared Charles Elms who on his oath declared that he is the same person who formerly belonged to the company commanded by Captain John Rhodes in the Regiment commanded by Col. Jethro Sumner in the service of the United States. That his name was placed on the pension roll of North Carolina but has never rec'd a formal certificate and now wants to receive one. I, William Hill, Secretary of State, in and for the State of North Carolina, do hereby certify, that it appears from the muster-rolls of the Continental line of this State, in the Revolutionary War, that Charles Elmes [sic] a private Soldier in Captain Rhodes' Company of the 10th Regiment, entered the service on the day of 1781 for the term of twelve months, and that it is said of him on said rolls, Time out 12 April 1782.

Be it hereby certify that satisfactory evidence has been exhibited before me Bruly Oates clerk of the Court of Pleas and Quarter Sessions in and for the County aforesaid, at my Office, that Charles Elms late of said County was a Revolutionary Pensioner at the rate of __ per annum, and that he died on the 5th day of January 1835 leaving no widow surviving him but left the following named children viz.: John, Ezekiel, Rebecca, Lucinda, and William W Elms – who are the only surviving children of the aforesaid Charles Elms.

"Charles Ellam [sic] Private of the United States Army Inscribed on the roll of the North Carolina Agency at \$5.60 per month. Formal certificate issued 28 January 1822 and sent to Isaac Alexander, Esq. at Charlotte, NC"]

[Veteran was pensioned at the rate of \$80 per annum commencing March 4th, 1831 and ending January 6, 1836 [sic].]

J. D. Lewis in his wonderful 3 volume opus listing all the NC soldiers he was able to identify who participated in the Revolution has this additional information regarding this veteran:

Charles Elms was a soldier in the 3rd North Carolina Regiment and fought at the battle of Germantown [October 4, 1777]. "[On] 10/28/1776, [he was] a Private under Capt. Jacob Turner for 2 ½ years. After Capt. Turner was killed, he was under Capt. Kedar Ballard. He lost an eye in the battle of Germantown, PA. [On] 9/9/1778, a known Private under Capt. Clement Hall (2nd North Carolina Regiment). Discharged on 5/1/1779. [In] 1781, a Private under Capt. Joseph T Rhodes (4th North Carolina Regiment) for 12 months. Discharged on 4/12/1782. When enlisted, lived in Bute County (now Warren County) North Carolina. Later lived in Mecklenburg County, North Carolina a.k.a. Charles Elloms, Charles Ellums, Charles Elmes."
