Pension Application of James Fling S8489 Transcribed and annotated by C. Leon Harris. 12 Feb 2014.

DISTRICT OF Columbia, ss.

On this Eighth day of June 1818, before me the subscriber, one of the Judges of the Circuit Court of the United States for the said district, personally appeared James Fling aged fifty seven years, resident in George Town [Georgetown] in the said district, who being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said James Fling enlisted in Stafford County in the state of Virginia in the company commanded by Captain John Mountjoy of the Sixth Virginia Regiment, that he enlisted the 12th day of January seventeen hundred & seventy seven; that he continued to serve in the said corps, or in the service of the United States until the 12th day of Jan'y, seventeen hundred & Eighty when he was discharged from service in little york state of [blank; probably York PA], that he was in the battles of Brandywine [11 Sep 1777] German Town [Germantown, 4 Oct 1777], Monmouth [28 Jun 1778] & Stony Point [16 Jul 1779] and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services.

Mr. Boyd Dear Sir

Will you help the poor man that takes this – James Fling who was of the 6th Virg'a Regiment during the Revolutionary War. he was born in the same neighbourhood with my self which adds to the solicitude I should otherwise feel to aid an old Soldier who Fought the Battles of his Country at that Critical period. James Fling has no papers he tells me with him but will distintly state his History and I have no doubt by referrence to the Military records of that day the history he gives of himself will be found to correspond

Statement of James Fling of Montgomery County Maryland. [13 Aug 1832] born a Mile & a half from the Mansion of George Brent Esq Stafford County Va.

The applicant on his Oath says that he was admitted by the General Government on or about 9th June 1818 to the Pension allowed to Revolutionary Soldiers. Which pension Deponent does not recollect receiving since the passage of the Act of Congress of the 1st may 1820 because Deponent was not willing to seek relief under that act by deposing to his circumstances in a Court of record. Deponent is over 70 year of age & has no real property

Deponent was a private in the 10th Virginia Regiment, in which he enlisted as he best recollects in January 1777 for 3 years, that Regiment being, during the struggle, reduced to the 6th Deponent served his Country faithfully for the period of his enlistment – sharing in the field engagements at Brandywine - Germantown - Monmouth and Stony point - besides several Skirmishes with the Enemy - and was ultimately detached under Capt'n Williams to Little York in charge of British Prisoners. Deponents residence at the time of his first application for a Pension was, as it has ever since been, in Montgomery County Maryland. That application was promoted by the late Robert Brent Esq'r, an officer of the General Government, to whom deponent was well known for many years & whose Testimonial in Deponent's behalf he believes is of record in the Archives under J. L. Edwards Esq'r. [Commissioner of Pensions] Deponent memorialized the War Department, & [illegible word] petitioned Congress for a Pension without success, his Property, tho small, excluding him from the class of indigent persons James Fling's mark X
