Pension Application of Richard Foggett S8498 Transcribed and annotated by C. Leon Harris. MD

STATE OF MARYLAND,/ ANNE-ARUNDEL COUNTY, SCT.

On this 30th day of October in the year of our Lord one thousand eight hundred and thirty two personally appeared in open court, before the Orphans Court of Anne-Arundel county, now sitting, Richard Foggett, a resident of the county of Anne-Arundel, and State of Maryland, aged 72 years, who being first duly sworn according to law, doth, on his oath, make the following declaration, in order to obtain the benefit of the Act of Congress, passed June 7, 1832:

That he entered the service of the United States, under the following named officers, and served as herein stated; that he served under Captain Lisbor Williams [sic: Lilburn Williams], that he entered the service on the [blank] day of [blank], in the year one thousand seven hundred and [blank], and left the same on the [blank] day of [blank] one thousand seven hundred and [blank]; that he had a discharge from Captain Bruce [William Bruce, pension application \$34668], but has lost the same that he was in the skirmish of Tangiers Island [possibly at the time of a naval engagement at Tangier Sound in Chesapeake Bay, 30 Sep 1782] and was at the siege of York when Cornwallis surrendered [19 Oct 1781] and in said engagements served under Captain Edward Spurrier, in the year one thousand seven hundred and eighty one; that he, at the time of entering the service, resided in Annapolis town, or City, in Anne Arundel county, and State of Maryland; that he enlisted; that he marched through Maryland & Virginia country; that he served with the Maryland troops; that the names of the regular officers were General [William] Smallwood Col. [Peter] Adams & Col [John] Stewart; That he was not wounded in the said battles or skirmishes, or any other; that he has documentary evidence; and that he knows of no person whose testimony he can procure, who can testify to his service. That he was born in Philadelphia in the year 1760, and has a record of his age, which may be found in the Parish Register, at South River Church in Anne Arundel County

The said Richard Foggett hereby relinquishes every claim whatever to a pension or annuity, except the present, and declares that his name is not on the pension roll of any Agency, but that of the Agency of the State of Maryland. Acat Inggett
