Pension application of Noah Harbour S8673 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia, to wit

On this 25th day of September 1832 Personally appeared in Open Court, before the Court of Halifax County now sitting, Noah Harbour a resident of the County and State aforesaid aged 75 years the 23rd of October next, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7th, 1832.

That he entered in this County in the service of the United States under the following named officers and served as herein stated. I volunteered as a militia man under Capt. James Turner in the month of April or May in the year 1776 and served six months and in a short time entered the service passed Petersburg, and Williamsburg to Guinn's Island [Gwinn Island, December 9, 1775] against Lord Dunmore [John Murray, Lord Dunmore, last royal Governor of the colony of Virginia], Col. Lewis [Andrew Lewis] commanded the Regiment to which he belonged: the commander of the Regulars was also named Lewis (rank not known or recollected) from thence he marched to Potomac River again to meet Lord Dunmore, from thence he marched westward against the Indians passed the mountains, crossed New River at English's Ferry and traversed the Wilderness to the Cherokee Towns on the Tennessee River still under the command of Col. Lewis -- two other regiments in the service at the same time under the command of Colonels Chesley & Williams, from that Tour he returned home the last of November or December he received his discharge from his Capt. which he has lost or mislaid -- again on the 26th of April 1781 I was drafted in the Virginia Militia for three months and marched in the service under his former Officer Capt. James Turner, and joined certain troops under the command of Major Rose at Salisbury North Carolina from thence, he marched into South Carolina to the District of Ninety Six and joined the Main Army under General Green [sic, Nathanael Greene], there he served his three months and was dismissed which discharge is either lost or mislaid. That he has no evidence of his said Service except the affidavit of William Wilson and Elisha Palmer¹. He hereby relinquishes every claim to a Pension or annuity except the Present and declares that his name is not on the Pension Roll of the Agency of any State. S/ Noah Harbour, X his mark

Virginia Halifax County to wit: Elisha Palmer a respectable person this day made Oath before me, that Noah Harbour of the County was a Volunteer Soldier in the Revolutionary War he believes & do believe served six months James Turner was Capt. & Fleming Bates was Lieut. as to the Col. he does not remember. Given under my hand & seal this [date obliterated by an ink blot] 1832.

Virginia, Halifax County to wit -- William Wilson a respectable Citizen this day came before me, one of the Commonwealth's Justices of the peace for the County aforesaid & made Oath, that sometime in the Year 1776 as well as he remembers, Noah Harbour, now of this County, with his brother, enlisted, or volunteered in the minute or volunteer service for six months in the revolutionary war, that he knows that he entered into the said Service, & he believes served their time out as they neither returned home within six months after that period. The said William Wilson also made oath, that in the year 1781 him and the said Noah Harbour was drafted in the Militia for three months & served their time completely. That James Turner was their Capt., Major Rose belonged to the Regiment to which they did & that they were at the Siege of Ninety Six.
