Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of Virginia Rockingham County: SS

On this 21st day of August in the year 1832 – Personally appeared in Open Court before Joseph Cravens, David Hinton, George Clarke & Augustus Waterman – The Justices of the County Court and composing the County Court of Rockingham now sitting – Christley Kapplinger a resident of the said County of Rockingham and State of Virginia aged eighty-two years the 10th day of March last past, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed the 7th of June 1832.

That he was born in the State of Pennsylvania in 1750 and was brought to Rockingham County State of Virginia by his parents about Eighty years since where he has continued to & now resides.

That he entered the service of the United States under the following named Officers and served as herein stated.

He first entered the service of the United States as a Drafted Militia man about the close of the year 1780, under Captain George Riddle [George Ruddle] & Colonel Nall [William Nolle or Nail], served at Edmonds Hill Virginia & in the State of South Carolina under General Muhlenberg [Peter Muhlenberg], served three months was regularly discharged in South Carolina received no written discharge.

That he entered the service of the United States the second time as a Drafted Militia Man in the year 1781 under Captain Cowyer or Cooker [perhaps Captain Michael Coger of Rockingham County militia], was marched immediately to the neighborhood of York Town Virginia and served there during the Investment siege & Surrender of Lord Cornwallis [October 19, 1781], was under the command of General Washington, the Commander in Chief during this tour, served 3 months was regularly discharged but received no written discharge.

That he has no documentary evidence and that he can prove his services as aforesaid by a certain John Moore a very old man whose attendance he endeavored to procure but could not, that he can prove by many others that he was drafted twice & went into the service of the United States during the Revolutionary War. That he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension Roll or Agency of any State.
