[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." [p 6] State of North Carolina, Edgecombe County: August Term 1832, Court of Pleas and Quarter Sessions

On this 28<sup>th</sup> day of August personally appeared in open Court before the Justices of the Court of pleas and quarter sessions now sitting Henry Kea, aged 79, a native of Surry County Virginia – now resident of the County of Edgecombe North Carolina who first duly sworn according to law doth on his oath make the following declaration, in order to obtain the benefit of the act of Congress of June 7<sup>th</sup> 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

He emigrated to this County from the place of his birth at a very early period of a life and entered the service of the United States in the company of Captain James Scarborough, of which company Jesse Howard was Lieutenant. This company was attached to the Regiment of Colonel Hy. Hart [Henry Hart], of which Regiment John Branch<sup>2</sup> was Lieutenant Colonel. The company having organized at Tarborough marched to Hillsboro and from thence to Salisbury and to New Providence, from which place he was attached to guard the baggage as the discharge from General Jones will show. The whole period occupied the term of three months for which time he had been drafted.

Soon after having returned home he was drafted into a Cavalry company of which company Malachi Moor [Malachi Moore] was Captain – Colonel Hart commanded the Regiment of which this company was a part. The duty he [did] then was mostly local – scouring the County in search for Tories and outliers which he would convey to Halifax and deliver them to Continental officers. He was thus employed for three months.

Deeming the discharge of General Jones sufficient he has not provided himself with other evidence to prove the facts set forth in the first claim of his declaration although Captain Scarborough is still in life. His evidence however he does not think important. The last clause he sustains by the oath of Nath Bilbry.<sup>3</sup>

He hereby relinquishes every claim whatever to a pension or annuity other than the present and declares that his name is not on the pension roll of any agency of any State.

[Veteran was pensioned at the rate of \$25 per annum commencing March 4<sup>th</sup>, 1831, for service as a private in the State Troops for 3 months and as a private of Cavalry for 3 months. Actually, it appears that all of the veteran's service was rendered in the Edgecombe County militia.]
