[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of North Carolina Rutherford County On this day of September personally appeared in open Court before the Justices of the Court of Rutherford County now sitting James Largent a resident of the United States in the County of Rutherford and State of North Carolina aged 80 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed the 7th of June 1832. Sayeth that he entered the Service of the United States under the following named Officers and Served as herein stated he thinks in the year 1775, he was living in Newberry District South Carolina at that time there was much stir in all gatherings between what was then called the King's men and the liberty man, I joined the liberty men under Capt. McCrary¹ the King's men forted themselves and the liberty men attacked them in their Fort and took it at that place² I received a wound in my thigh went home and soon recovered as soon as I was able I shouldered my Rifle we was at all times ready to serve we was called out on duty very often but I do not recollect any engagement nor do I recollect any General Officer that we was under some in the year 1777 I moved to Rutherford County North Carolina under Capt. Micajah Lewis for 9 months we was ordered on immediately to the State of Virginia to join General Lincoln [Benjamin Lincoln] we was marched to Dan River on the Virginia line at that place our course was changed I recollect on our return we passed through Moravian town then to Ninety Six in South Carolina where we was stationed a short time from that station we was moved on to Bacon's Bridge there I recollect to have seen General Lincoln we was from that place marched to a Fort near Augusta on the South Carolina side we was there but a short time we were marched down the River to Beach island from there to Purrysburg to the Two Sisters ferry from that place to the battle at Stono [Stono Ferry, June 20, 1779]³ where we had a warm time and several of my acquaintances fell by my side at that place I think General Lincoln commanded we was sent from that place to Bacon's Bridge where my term of service expired and I was discharged returned home to Rutherford County North Carolina I immediately became a volunteer in a troop of Course for 10 months under a Capt. James Mucklebaney [sic, James McElhaney] the Regiment

was commanded by a Col. Hammond we was sent on to near Augusta we was kept out as Scouting parties and spies we was a Fort Granby when we was ordered on to Eutaw Springs on our march I was to that place was sent as one of a guard with some gentlemen to Augusta before we returned the Battle was over I heard [indecipherable word, looks like it starts "Quart.."] was a [at?] Granby at that place my term of service expired I returned home to North Carolina I shortly after became a volunteer for 3 months under the command of Capt. Robert Gilkey to Charleston where we was stationed we was at that place when we heard that Cornwallis was taken [Yorktown, October 19, 1781] a very soon after we was all Discharged when we returned home. I am entirely illiterate have no memorandum to cause me to recollect dates I am old and forgetful of many of the transactions that took place One thing I know I spent the prime of my life in the defense of my Country and am not able to work for my support and I have not any other way to make one and now call on the Bounty of my Country to support me in my Decline I will [sic, well] know that from the commencement of the War I was engaged in the Defense of my Country to the taking of Cornwallis I was one of the first in the District of Newberry South Carolina who joined the liberty men at that time we had to contend at the least against two to one I was at that time a very stout and strong man I fought and bled for my country's cause and lost all I had but myself who is at this time poor weak and feeble

He hereby Relinquishes every Claim whatever to a pension or annuity except the present and Declares that his name is not on the pension Roll of the agency of any State. Sworn to and subscribed the day and year aforesaid.

Answer I was born in Anson County North Carolina in the year 1752

Question 2nd Have you any record of your age and if so where is it?

Answer: I have the record of my age now in my possession

Question 3rd Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Answer: I was living in Newberry District South Carolina when I was first called into service I came to Rutherford County in the time of the Revolutionary war and settled where I have lived ever since

Question 4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

Answer: My first service was a volunteer for	9 months
my 2nd and was in the light horse	10 months
my 3rd was draft	3 months
I was for all the space between this	

service engaged in scouting parties say 3 months 25 months

I have bargained & sold & by these presents Do bargain & sell unto Andrew Hampton all the wages & Bounty Due to me the said Largin [sic] for services done in Captain James McElhaney's Company of 10 months Dragoons in the State of South Carolina which bounty agreeable to the articles of my Enlistment with all & every Claim thereof the said James Largin will Warrant & forever Defend unto the said Andrew Hampton from All Just Claims. In witness whereof I have hereunto set my hand & seal this 2nd Day of April 1782
