Pension application of Isaac Lucado S8869 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

At a Superior Court of Law continued and held for Fluvanna County on Wednesday the 27th day of May 1818 –

This day Isaac Lucado aged sixty-two years resident of the said County personally appeared in Court and made the following declaration on oath. That he entered the service of the United States as a private soldier in the War of the Revolution on or about the ninth day of February 1776, that he belonged to a Company commanded by Captain Charles Fleming of the seventh Regiment commanded by Colonel Dangerfield of the Virginia line on the Continental establishment that he served as a soldier as aforesaid for two years and quit the service in consequence of being discharged which discharge is lost or mislaid, and that he is in reduced circumstances and needs the aid of his Country for support which fact aforesaid as respects said service was supported by the testimony of George Rhodes¹ a witness sworn in open Court. And it appearing to the satisfaction of the Court that the said Isaac Lucado served in the Revolutionary War as aforesaid against the Common Enemy for at least the term of two years, and that he is by reason of his reduced circumstances in life in need of assistance from his Country for support and has therefore a just claim to a pension in the manner prescribed by an Act of Congress entitled "An act to provide for certain persons engaged in the Land and Naval service of the United States in the Revolutionary War" the same is ordered to be certified to the Secretary of the Department of War.

State of Virginia Fluvanna County to wit

On the 25th day of July 1820 personally appeared in open Court being a Court of record for the said County proceeding according to the course of the common law with a jurisdiction unlimited in point of amount keeping a record of its proceedings and expressly made a Court of record by the laws of the said State Isaac Lucado aged sixty-four years resident in said County who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war as follows. That he entered the service of the United States as a private soldier in the war of the Revolution on or about the ninth day of February 1776 that he belonged to a company commanded by Captain Charles Fleming in the seventh Regiment commanded by Colonel Dangerfield [William Dangerfield, sometimes spelled William Daingerfield] of the Virginia line on the Continental establishment and that he served as a Soldier as aforesaid two

years and quit the service in consequence of being discharged which discharge is lost or mislaid. And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed to wit Three plows, five hoes, two sets of Plow geer, three pots, two ovens, three pair of pot hooks, one frying pan, one skillet, two dishes, three bowls, three basons, one dozen plates and set cups and saucers, one case knives & forks, one pitcher, one cupboard, one coffee pot, eight chairs, two butter pots, one table, two axes, one handsaw, one drawing knife, one auger, three chest, two looms, one flax wheel, one pale [pail], one tour of, two piggins, one churn, one can, one cotton wheel, one looking glass, one pair wedges, one Scythe, two Slays [?], three horses, eight head of Cattle, ten sheep, fourteen hogs and one hundred acres of Land. The said declarant states that he is by occupation a farmer and planter that by reason of age, ill health and infirmity he is unable to perform any labor but that of the lightest kind. His family consist of a Wife aged about fifty-two years two daughters one aged about thirty years who has the use of one hand only and one of her legs contracted so as to impede her walking, the other aged about twenty-seven years, also two sons, one aged about seventeen years and the other aged about fifteen years also a little Girl about ten years of age taken into the family to prevent her from suffering, none of which are able except the sons to contribute to their support but in a small degree. In the said declarant further states that the number of his original Certificate is 15905

State of Virginia Fluvanna County to wit

On this 23rd day of July 1832 personally appeared in open Court being a Court of record for the County aforesaid Isaac Lucado resident in said County who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June seventh 1832, to wit: That he the said Isaac Lucado received a pension under the Act of March 1818 for a short time. That his name was struck from the pension roll by reason of his property as was thought by the Department property sufficient for his support. His property at that time was valued at \$704, but has been reduced to less than \$200 that the said Isaac Lucado enlisted in the State of Virginia in February 1776 in the Company commanded by Captain Charles Fleming in the Regiment commanded by Colonel Dangerfield, that he was discharged in Lancaster Pennsylvania in February 1778 by Colonel Gibson, that he served agreeable to the terms of his enlistment as a private soldier for two years – That he is and has been for the last thirty years a resident of the County of Fluvanna. That he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any State, that the evidence of his services are in the proper Department at Washington –

[Veteran was initially pensioned under the 1818 act at eight dollars per month but his name was struck from the list in 1820 as result of his having too much property to qualify under the 1818 act as indigent. He was later pensioned at the rate of \$80 per annum commencing March 4th, 1831, for service as a private for two years in the Virginia service.]
