Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Virginia County of Fauquier to wit;

On this 29th day of November 1832, personally appeared in open Court before the Justices of the County Court of Fauquier it now sitting William Payne a resident of the County of Fauquier and State of Virginia aged 73 years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7th 1832.

I enlisted in the service of the United States in the summer of 1775, and in the fall, the first of September of the same year I marched to Williamsburg from thence to the Great Bridge and from thence to Norfolk, I continued with the Battalion until it's discharge in March 1776, I was at the battle of the Great Bridge [December 9, 1775] and at Norfolk when that city was burnt [January one, 1776]. William Pickett was the Captain and John Marshall (now Chief Justice of the United States) was first Lieutenant. I was Sergeant. The Brigade was commanded first Colonel Taliaferro, afterwards by Colonel Stevens [Edward Stevens]. – I entered the service again, on first November 1778 under the command of Captain Hezekiah Turner – Martin Pickett was our Colonel, I marched from Fauquier County, crossed the Potomac [River] at Noland's Ferry, from thence through the State of Maryland, and thence to the State of Pennsylvania. I was at the battle of Germantown [October 4, 1777], and then returned to the City of Philadelphia, and then we returned home having served three months and some days. I entered the service again in the winter of 1780 and served until the spring of 1781. I first marched to Williamsburg from thence to Richmond, the tour lasted four months and twenty days. I went under the command of Captain O'Bannon – Colonel Churchill [Armistead Churchill] commanded the Regiment – before we left Richmond, we were joined by Lafayette.

Question. Where and in what year were you born?

Answer I was born in Fauquier County, State of Virginia in the year 1758.

Question. Where were you living when called into service where have you lived since the revolutionary War and where do you now live.?

Answer. Always in the County of Fauguier, State of Virginia

Question did you ever receive a discharge?

Answer. I never did; I always served my time out, and never applied for one.

Sworn to and subscribed the day and year aforesaid.

that my name is not on the pension roll of the agency of any state whatever. Subscribed and sworn to the day and year aforesaid.
