## Pension application of Samuel Marshall S8997 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Samuel Marshall whose heirs claim a Pension for his services as a Soldier in the Revolutionary war, lived on Saxes Island in Accomack County and State of Virginia, and died on or about the 15<sup>th</sup> day of February 1835; and that he left the following children viz.; Washington Marshall, Milly Lewis and Elizabeth Tyler, who were the only living children at his death.

State of Virginia Accomack County: SS

I John W Gillet, Clerk of the County Court of Accomack County in the state aforesaid do hereby certify that the foregoing are true transcript from the records of said court. In testimony whereof I have hereunto set my hand and affixed the seal of the said court this 11<sup>th</sup> day of October 1851 and in the 76<sup>th</sup> year of the Commonwealth.

State of Virginia, Accomack County, Sc:

On this 29<sup>th</sup> day of September 1851 personally appeared in open Court, before the Court of Accomack now sitting James W Custis a resident of the County and State aforesaid, Administrator of Samuel Marshall, a revolutionary soldier, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain for the children of the aforesaid Samuel Marshall the benefit of the Act of Congress passed June 7<sup>th</sup> 1832 –

That it appears by the affidavit of Robert Chase, a Revolutionary soldier and a Pensioner of the United States, dated June 17<sup>th</sup>, 1832, that said Chase served with the said Marshall in keeping guard in the Revolutionary War, on Crooked Creek, which is at this time called Holding's Creek – That, the said Samuel Marshall was according to the affidavit of Robert Chase, dated the 10<sup>th</sup> day of July 1851, enrolled in a Company of Militia commanded by Captain Jesse Dickerson under the command of Colonel Southey Simpson. Robert Chase further certifies that he believes that said Samuel Marshall, was in service two years or more – I further declare that it appears by the affidavit of Robert Corbin<sup>2</sup> a revolutionary soldier dated 1832, that the aforesaid Samuel Marshall, was a Soldier in the revolutionary war, and that, he served with him in keeping guard at \_\_\_\_

The testimony of these 2 respectable persons made immediately after the passage of the law on January 7<sup>th</sup>, 1832 [sic, June 7<sup>th</sup>, 1832], is I think conclusive of the service of the aforesaid Samuel Marshall. – I have no record of said Marshall's age but from the age of his children now

living it would not have been less than ninety years at the time of his death,. I hereby as his administrator relinquish any claim whatever to a pension or annuity except the present and declare that his name is not on the Pension roll of the Agency of any State. Sworn to and subscribed the day and year aforesaid.

I Robert Chase aged about 90 years and a Revolutionary Soldier and a pensioner of the United States do hereby certify that I am well acquainted with Samuel Marshall of Sixis [sic] Island and I know he performed Military duty in the War of the Revolution. He served in a company of Militia commanded by Captain Jesse Dickerson under the command of Colonel Southey Simpson and I know Samuel Marshall Guard at holding's Creek in the County of Accomack I served with him at the above place in the year 1778 or 79 I cannot after this long lapse of time say accordingly how long he served but from my knowledge of the many tours he served I am satisfied he served more than 2 years owing to the exposed condition of the County all of the militia Companies were frequently called out on tours to keep guard to repel the enemy & protect the County from the depredations. These Militia Companies were frequently called out on tours of several months duration during the whole war and I am satisfied that no Company Dunmore duty than Captain Jesse Dickerson's in which Samuel Marshall was enrolled.

This

[The heirs of the veteran were allowed a pension at the rate of \$80 per annum commencing March 4<sup>th</sup>, 1831 and ending February 15, 1835 for the services of their ancestor as a private in the Virginia line.]
