Pension application of Edward McKay S9016 Transcribed by Will Graves f15NC 2/13/09: rev'd 1/18/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina Cumberland County: Court of Pleas & Quarter Sessions September Term 1832

On this the 3rd day of September A.D. 1832 personally appeared Edward McKay in open court before the Court aforesaid resident of the County aforesaid aged about 73 or 75 years of age and after being duly sworn according to law doth on his oath, make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832.

That he was drafted into the Militia of the State of North Carolina about the year 1782, and served first under one Capt. McCranie [Neil McCrany] and afterwards under one Capt. Archibald Smith of the County aforesaid, that he was employed in herding the cattle and in driving them to the Army in South Carolina, then under the Command of General Green [sic, Nathanael Greene], that he assisted in driving said cattle to the Camp of Greene then at Ashley Hill near Charleston, that after staying some time in Greene's Camp, they marched back to Cross Creek in Cumberland County, now known as the Town of Fayetteville, That he served with one Morris Morrison, whose affidavit is hereunto appended, that he was in no battle nor was never wounded. That he knows of no other person to prove his service but the said Morrison, that he had a discharge but has lost the same -- that he has no documentary evidence to prove his service -- That he then resided and has resided ever since in the County of Cumberland, that there is no Clergyman in his neighborhood from whom he can obtain his certificate -- That he was born somewhere about 1756 or 1759, that has no record of age, and lived in the County of Cumberland when called into service, that he was drafted, that his discharge was signed by his Capt. Archibald Smith. That his neighbors Neill Munroe & ___ can prove the respectability of his character -- and can testify as to the repute in his neighborhood that he served in the Revolutionary War -- That he only served 6 months.

He hereby relinquishes all claim whatever to a pension or annuity, except the present & he declares that his name is not on the pension roll of the agency of any State. Sworn to and subscribed the day and year aforesaid.

Personally appeared before the Court aforesaid Morris Morrison, and after being duly sworn according to law, doth on his [oath] say, that he served with Edward McKay in the manner as above stated by said McKay, first under Capt. McCranie and afterwards under Capt. Archibald Smith, that they were employed in herding & driving cattle to the Army in South Carolina under General Greene, that they drove of cattle to Ashley Hill in South Carolina where Greene was then encamped, that they afterwards marched to Cross Creek where they were discharged -- that they were drafted in 1782.
