[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina, York District SS

On this 16th day of October 1832 personally appeared in open Court before Wm. D. Martin Judge of the court of Sessions and Common Pleas, now sitting, Jacob Black a resident of York District State of South Carolina, aged in his Seventy fifth year who being first duly sworn according to law, doth make the following declaration in order to obtain the benefit of the act of Congress passed the 7th June 1832.

That he entered the Service of the United States as a volunteer in the month of January 1779, and Served two weeks, against the Tories, on Fairforest Creek in South Carolina under Captain Thomas Kirkpatrick. -- That he was drafted and served three months, in an expedition to the State of Georgia. That during this campaign, he was in the Battle of Briar Creek; where General Ashe [John Ashe of North Carolina] was Defeated by the British General Prevost [Augustine Prevost]. That in this tour he served under Captain Thomas Kirkpatrick & Major Ross [Francis Ross]--:

That in the month of December 1789, he was drafted and served a three months tour to Charleston South Carolina, under Captain Thomas Black & Col. Samuel Watson. --

That in the month of June 1780 he volunteered on a tour against the Tories in North Carolina & Served one month under Captain George Hodge [of Orange County, NC] & Major McDaniel [probably Eli McDaniel of Orange County, NC].

That in the month of August 1780 he volunteered under General Thomas Sumpter [sic, Thomas Sumter] and served four months, --. That this tour he was commanded a part of the time by Colonel Campbell [William Campbell of VA], and was sent on a Detachment against a body of Tories supposed to be near Smith's Ford South Carolina which prevented his being in the Battle of King's Mountain; and in this tour he was in the Battle at Blackstock's under Captain James Jamieson & General Thomas Sumter.

That on the 15th of December 1780 he again volunteered as a guard to 24 wagons to go to New Bern in North Carolina for public Stores for General Sumter's Army. That they were driven back into Virginia by the British General Cornwallis. That in this expedition he served four months & was commanded by Captain Wm McCulloch [William McCulloch].

That about the first of May 1781 he volunteered and served five weeks at the Siege &

taking of Congaree or Friday's Fort, ³ commanded by Captain John Kirkpatrick & Colonel William Bratton.

That about the first of July 1781 – he again volunteered, and served a tour of two months, and was one of a party who drove the British from the quarter house 6 miles from Charleston South Carolina commanded by Captain Ephraim Woods & Colonel William Bratton.

That about the last of June 1782 he again entered as a volunteer, and served two months on the Edisto under Lieutenant Woods & Captain commandant William Hanna.

That during these different periods of Service he was not at any time Stationed, with any of the Continental troops, except three days with General Greene [Nathanael Greene] near Orangeburg South Carolina. That according to the best of his knowledge, he was born in the County of Nottingham, State of Pennsylvania on the 15th day of July 1758 – That he has no record of his age. That when called into the service of the United States he resided in what is now York District South Carolina, and that he still resides in the same. That he never Received any written discharge from the Service, except for his four months, tour to North Carolina under Major McDaniel which Discharge is lost.

He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State.

1st Where and in what year were you born?

Answer: In Nottingham County in the State of Pennsylvania, and on the 15th day of July in the year 1758.

2nd Have you any record of your age and if so where is it?

Answer: none

3rd Where were you living when called into service: where have you lived since the Revolutionary War and where do you now live?

Answer: on Broad River, near Pinckney ferry

4th How were you called into service; were you drafted; did you volunteer or were you a substitute, and if in substitute, for whom?

Answer: the first Tour he entered the Service of the United States as a volunteer in the month of January 1779, and served two weeks against the Tories, on Fairforest Creek in South Carolina under Captain Thomas Kirkpatrick --

the second Tour he was drafted and served three months in an Expedition to the State of Georgia; that during this Campaign he was in the Battle of Briar Creek where General Ashe was defeated by the British General Prevost, that in this Tour he served under Captain Thomas Kirkpatrick and Major Ross

5th State the names of some of the regular officers who were with the troops when you served, such Continental and militia regiments as you can recollect and the general circumstances of your service.

Answer: My officers were Captain Kirkpatrick, Colonel William Bratton Captain James Jamison & others referred to in my Statement at large, to which I refer you for the general circumstances of my service.

6th Did you ever receive a discharge from the service, and if so, by whom was it given and what has become of it?

Answer I received none being a private

7th State the names of persons to whom you are known in your present neighborhood and who can testify as to your character for veracity and their belief in your services as a soldier in the revolution.

Answer I can refer you to all my neighbors, but will only named William Jamison Esq. & Captain James Jamison.
