State of North Carolina, Orange County

On this the 27th day of May 1835 personally appeared before the undersigned an acting Justice of Orange aforesaid Benjamin Carroll¹ a resident Citizen of Orange aforesaid and an United States pensioner about 82 years of age Being first duly Sworn according to law deposeth and saith that during the War of the Revolution he was acquainted with Jonathan Dollar late of Orange County aforesaid deceased and remembers of being in a 12 months service with said Dollar their officers as well as he remembers was Colonel Armstrong & Col. Dickson [sic, Henry Dixon] & Colonel Little [sic, Archibald Lytle] all of whom was under the Command of General Greene [Nathanael Greene] also states that they were together at Pond Ponds [sic, Pon Pon River, a/k/a Edisto River]² and from thence to Beytons [sic, Bacon's] Bridge on Ashley River and then went down the said River to High Hills for the purpose of getting good water while he was at Bacon's Bridge peace was made and we procured our discharges and returned home sometime in the fall Season of that year and the said Benjamin Carroll further states that Jonathan Dollar stated to him during their service together that he Jonathan Dollar had served two militia Tours of three months each previous to his enlistment for the term of 12 months.

I William Hill Secretary of State in and for the State aforesaid, do certify it appears from the musterrolls of the Continental line of this State in the revolutionary war that Jonathan Dollar a private in Captain Armstrong's Company of the 10th Regiment, enlisted in the year 1781 for __ [blank in original] and left the service on the first day of July 1782.

Given under my hand this 31st day of March 1835.

Personally appeared before me Nathaniel J. King, one of the Justices of the Peace for the County of Orange, James Dollar,³ who maketh oath that Jonathan Dollar of the County and State aforesaid, was a Private in the war of the Revolution and that he served with James Dollar, the signer of this certificate, three months, and that it was with the signer of this certificate at General Gates' defeat (year not recollected) and that Jonathan Dollar did not absent himself from service, during said time.
