Pension application of Benjamin Isbell S9358 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Virginia Goochland County

On this the 17th day of September 1832 personally appeared in open court before the justices, the court of Goochland County now sitting, Benjamin Isbell a resident of the County of Goochland and State of Virginia, aged Sixty-nine years, who being first duly sworn according to law, doth on his oath, make the following declaration, in order to obtain the benefit of the act of Congress passed June 7th 1832.

That he entered the service of the United States under the following named Officers, and served as herein stated. About twelve months after Burgoyne was taken prisoner [October 7, 1777] & with his men carried to the Albemarle Barracks about seven miles above Charlottesville, he was detailed as a guard to guard the Prisoners under the command of Captain Elisha Leake [Elisha Leak] of Goochland County – David Rutherford was either Lieutenant or Ensign, he can now recollect which - He marched to the Albemarle Barracks and there remained there between four and five weeks until relieved by other guard. He thinks Colonel Bland [perhaps Theodorick Bland] was the commanding officer at the Barracks at the time he was doing duty as guard there. From thence he returned home and in about a year or probably more thereafter, he was detailed under Captain Edward or Edmund Curd and rendezvoused at the rope works below Richmond and was attached to the command of either Colonel Richardson or Colonel Morris both being there, they went below Richmond to Morban Hills [Malvern Hills] & marched & countermarching about the country in that neighborhood and in & about four weeks returned home. In 1781 I went under Captain Leake to Richmond at the time Manchester was burnt by the British [April 30 1781] & changed to Captain Miller [perhaps William Miller], then joined the Marquis Lafayette and marched from Richmond to Colonel Dandridge's in Hanover; from thence to Scotch town in Hanover, thence into Spotsylvania; from Spotsylvania to Culpeper where we met General Wayne [Anthony Wayne] not far from the Raccoon Ford, we then returned & crossed the Rapidan [River] at the Raccoon Ford where we remained a few days; thence marched into Orange, from thence to Boswell's old Tavern in Louisa, from thence we came in to Fluvanna & cleared a road which to this day is called the Marquis' road, & then encamped on Machank Creek [Mechunk Creek] for some time; thence we marched down Louisa in the woods between the three notches road & the old mountain road, & then we went to a Creek called Camp Creek; thence to another Creek name not recollected; thence to Fork Creek; thence to Deep Creek where I obtained a discharge & returned home, which discharge I have lost. – In that tour, I was out about six months & probably a half. He has no documentary evidence. My brother Henry Isbell, Captain Stephen Mayo of Fluvanna County are living as I

believe who can testify as to the most of my services. He has resided in the County of Goochland being born in that County from the time he received his discharge (except five years in Buckingham County & one in Hanover) until the present time. He never received any pay or compensation for his services. He relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any state.

State of Virginia Goochland County: SS

On the 20th day of May 1833 before the subscriber a Justice of the peace in and for the County aforesaid personally appeared Benjamin Isbell a resident of said County and being duly sworn doth on his oath make the following amended declaration in order to obtain the benefit of the Act of Congress of the 7th June 1832. That in his first tour as set forth in his former declaration, he served one month as private in the infantry. That his second tour as formerly stated, under Captain Curd he also served one month, in the same grade. And that in his third tour under Leake, then Miller, then Toles [Stockley Towles], as mentioned before, he served six months in the said capacity of private of infantry –

To Question 1st he answers. In Goochland Virginia 18th of March 1763

To Question 2nd I have a copy from the parish register –

To Question 3rd I have always lived in this County except 7 years; since the war, when I lived in Buckingham Hanover and Louisa counties in Virginia –

To Question 4th I was a substitute for my Brother Lewis in the Barracks, and was drafted after the other tours

To Question 5^{th} – I sold Colonel Bland at Charlottesville, and in his last tour I saw Generals Lafayette and Wayne. I saw the regular Army in my last tour. I recollect General Nelson and Colonel Lindsay of the militia and no militia regiments in particular. I served at the Barracks in Albemarle and marched under Captain Curd to the Eastern part of the State, and in my last tour was in the wild goose Chase

To Question 6th I received a discharge from Captain Toles only, and that I have lost – To Question 7 Colonel Dabney of Louisa, Colonel Joseph Shelton and Mr. James Wheary of Goochland.

State of Virginia Goochland County: SS

Personally appeared before me John Underwood a Justice of the peace in and for the County Anthony Layne a resident of the said County and State and a credible person and being duly sworn according to law on his oath saith that in the spring of the year '81 he served in the Virginia Militia in the Country below Richmond, a two months tour, and that during the whole of the time Benjamin Isbell of said County and now an applicant for a pension was in the service with him under Captain Miller, and that when he left the Army said Isbell continued in the service and he believes said Isbell continued to serve for some time longer. And also Henry Isbell² a resident of said County and also as appears to me a credible person, and being also duly sworn deposeth that Benjamin Isbell of the County aforesaid served a tour at the Barracks in Albemarle in the fall of 1779 under Captain Leake; and also the said Isbell marched in the winter 1780 towards the lower part of the Country under Captain Occurred and that he was from home some time and he verily believes said Isbell continued in the service the whole tour. And moreover that said Isbell marched with him into service again in the spring of '81 under Captain Leake – that they served together some time and when he returned said Isbell continued in the service and did not return home till late in the summer.
