## Pension application of James Medford S9411 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## State of North Carolina Martin County

On this day personally appeared before me Figures Lowe one of the Justices of the Peace for said County -- James Medford a resident of the said State & County who being first sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832.

That he was drafted for three months service in the revolutionary war at Williamston in said County -- & went to the South under the command of Capt. John Jones [John Higgins Jones] & Lieut. James Jones. He was marched through various places and finally to Charleston in South Carolina & after falling into the Main Army he was under the command of Col. Etherington [Lieutenant Colonel Jeptha Eatherton]. He was with the baggage wagons at this battle of Briery Creek [sic, Briar Creek, March 3, 1779] being prevented from joining in that engagement by sickness. Although only drafted for three months he was not discharged until after the expiration of four months.

He was drafted a second time & placed under the command of Capt. Crowell [Samuel Crowell] of Halifax & was marched through the upper part of this State to Camden in South Carolina. The commanding field officers were Col. Read [James Read] & Major Webb [John Webb]. He was in a little skirmish with the British at Santee River. He was then marched back to North Carolina and was within a mile of the battle ground of Guilford Court House [March 15, 1781] proceeding to the assistance of our forces when they were met by the American troops retreating. From this place he was marched to Wilmington in this State & at the expiration of four months he was discharged. He received written discharges both tours the first by whom he does not recollect the last he thinks by Major Pointer [perhaps John Poynter of Currituck County NC who is known to have been at Briar Creek]. He knows of no person by whom he can establish his service except the affidavits hereunto annexed. He was born & raised in this County & is now Seventy-five years old. He hereby relinquishes every claim whatever to a pension or annuity except the present & declares that his name is not on the pension roll of the agency of any State.

Sworn to & subscribed before me the 18th day of March 1833

[Veteran was pensioned at the rate of \$26.66 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 8 months in the North Carolina militia.]
