## Pension application of Miles Howell S9586 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." In Nansemond County Court 13<sup>th</sup> May 1833 State of Virginia, County of Nansemond SS

On this 13<sup>th</sup> day of May 1833 personally appeared in open Court, before Josiah Riddick, Hardy Cross, Edward R Hunter and Edward B Sumner the Court of Nansemond, now sitting, Miles Howell a resident of Nansemond County and State of Virginia aged seventy-two years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832. That he entered the service of the United States under Captain Robert Riddick, Captain Foster, Captain James McClenny Captain Willis Parker and Captain Kinchen Godwin – Josiah Riddick and Book Wills were his different colonels – that he served under the above named officers eight or ten different tours of six weeks each, making in all at least twelve months service, that he marched to Portsmouth, and was several times on James River, that he was drafted in the service that he resided in Nansemond County State of Virginia when he entered the service, that he was in a skirmish with the enemy at troublesome point on Nansemond River that he recollects there were regular troops at Portsmouth, but does not, at this time recollect the number of the Regiment or the names of the officers that he was on James River at the time the battle was fought at Little York that he was discharged at Portsmouth by Captain Foster, does not recollect whether he received a written discharge or not, and that he has no documentary evidence to offer in support of his claim. He hereby relinquishes every Claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any state. Amended declaration of Miles Howell State of Virginia, County of Nansemond

I, Miles Howell of the aforesaid County and state, being duly sworn according to law doth on my oath make the following amended declaration in order to obtain the benefit of the provision made by the Act of Congress, passed June 7<sup>th</sup> 1832. – That by reason of old age and the [the image of this page cuts off at the bottom thereof at this point] [next page]

recollection, I served during the war in the militia a period not less than eleven months and six days, and for which service I claim a pension. – That to the best of my recollection, I entered the service of the United States in the year 1778 under Captain Robert Riddick, under whom I served

two tours of six weeks each; during the same year I served one other tour of six weeks under Captain Foster – in the year 1779 I served two tours of six weeks each under Captain James McClinney and one tour of six weeks under Captain Willis Parker, and in 1780 I served one other tour of six weeks under Captain Willis Parker, and one six weeks under Captain Kinchen Godwin, making in all eight tours, not recollected, of six weeks each. (I said in my original declaration that I served twelve months, because I calculated four weeks to be the month.) Colonel Josiah Riddick of this County and Colonel Book Wills of Isle of Wight were the field officers, who commanded generally when I was in service –

That I was called into service by Competent authority that my service was performed in the field in the counties of Nansemond, Norfolk, Isle of Wight and Surry Virginia, that I was not engaged in any civil pursuit during the performance of this service, and that I know of no person now living who can testify to the length of my service. Sworn to and subscribed this 9<sup>th</sup> day of November 1833

[Veteran was pensioned at the rate of \$32.66 per annum commencing March 4<sup>th</sup>, 1831, for service as a private for 9 months and 24 days in the Virginia militia.]
