[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the House of Representatives

The Humble Petition of William Adams Sheweth, That your petitioner at an early period of the Revolutionary war entered into the Service of his country as a private soldier under the command of Captain Joseph Calhoun; and that he continued to serve his Country in different capacities till the end of the war, part of the time acting as a private soldier, and the remainder as a Sergeant and Lieutenant read that he further contributed to the service of his country by acting as a Waggoner and furnishing supplies of provision. That by these Several Services he had a just charge against this State to the amount of Eighty-seven pounds Fifteen Shillings Sterling, as appears by a certified transcript of the Accounts kept by General Robert Anderson in which is hereunto annexed. That a return was made of the said account by the said Robert Anderson in September 1783. That your Petitioner has never been able to obtain his indent for this sum, or any other, although he has made several applications at the Treasury Office for it. That he has been informed that it has been drawn by some person unknown to him, and unauthorized by him from the said office. Your petitioner is also informed that the person so drawing his indent as not even left a pretended order from your petitioner, and that in the receipt his name is so obscurely wrote, as not to be illegible. Your petitioner regards his case, as an extremely hard one, in as much as he is thus deprived of the hard earned reward of his meritorious Services, without any the neglect, or default of his own, but wholy by the misconduct of an officer appointed by the State. Your petitioner hopes that your Honorable body will take his case into consideration and in regard to the justice and Equity of his claim; and the extreme hardness of losing many years of laborious and hazardous services in a war which has terminated so gloriously and fortunately for his Country, Grant such relief in the premises as to your Honors may seem meet and your petitioner as in duty bound will ever pray &c.

The amount of Lieutenant William Adams' Account, during the Revolutionary War with Great Britain, for Personal Services, as Private, Sergeant and Lieutenant, for Waggon Service and supplies of provisions, as Returned by me in September 1783 is Eighty-seven pounds fifteen Shillings, £87.15, Sterling, as it is now taken from a Transcript of the said Accounts kept in my possession

Personally Appears before me William Adams and being duly sworn saith that he never empowered anyone to draw the indent due from this State to him for services during the Revolutionary war from the treasury office, nor gave an order to that effect except Colonel Joseph Calhoun; and that he never received said indent, or been compensated for his service aforesaid.
