Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

This Day personally appeared James Saxtson [sic] before me a soldier in Colonel William Polk's Regiment and made oath as the Law Directs that by his services in the State Troops of South Carolina Commanded by General Sumpter [Thomas Sumter] – and I the soldier James Saxton is justly entitled to a Negro – according to the tenor of Enlistment made by the said General and that he the said James Saxton Did not violate the said title Nor sell Nor Dispose of the said Negro to any person whatsoever but to George Harris who has purchased the same from me this Receipt will be Good to the public and No other. Sworn before me S/ John Foard, JP S/ James Saxton, X his mark

The aforesaid James Saxton appears and makes the oath by Law Directed that he Never converted to his own use any horses, saddles or bridles, arms or ammunition or Clothing or any thing belonging to the public of South Carolina. Sworn before me February 1, 1783 S/ John Foard, JP S/ James Saxton, X his mark
