Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

To the Honorable the Speaker & Members of the Honorable House of Representatives The Petition of William McCrea, Mariner **Humbly Sheweth**

That your Petitioner hath been in the Service of this and the United States during the late War, and has always acted as a Vigilant and upright Officer ought to do; and from his attachment to the Cause of America as met with many Misfortunes, in consequence of his being made a Prisoner 14 times, which has reduced him to low Circumstances; he therefore Petitions this Honorable House, that when an election shall take place for a Tide Waiter for the Harbor of Charleston to give their Suffrages in his favor, which will be duly acknowledged; the uprightness of his Conduct can be fully evinced by many of the Honorable Members of this House, having been a resident of this State upwards of twelve years past.

And Your Petitioner as in Duty bound will ever pray

At Charleston 26 June 1786 this Certifies that William McCrae [sic] did Duty in my Company as a Private Grenadier for a Considerable time during the War and always behaved himself as a Good Citizen and Friend to the United States of America.
