[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 7] 5<sup>th</sup> Day May 1784 – I have this Day received from General Richard Winn, the full value of my Account against the Public, now lying in the Auditor's Office for auditing, and afterwards to get an Indent for the same from the Treasury and I do request the Commissioners of the Treasury of the State of South Carolina, to make out the Indent for the same with the Interest pursuant to the Resolve of the Legislative in that Case, to him, the said Richard Winn and to accept this as a Receipt in full against the Public for the said Account. S/ Major Parsons, X his mark

South Carolina Pendleton County I do hereby certify that Captain Major Parsons had three accounts for personal Service and three other Accounts all returned by me into the Auditor's Office one for supplies to the Army amounting to £377.5/ old Currency, Another for the same, amounting to £39, like money, and one for a horse lost in the service, appraised at £150 old Currency per

Captain Major Parsons made oath before me that he never received any Indent or Indents, or other restitution, for any of the three last mentioned Accounts – That he furnished the provisions by the order of Col. John Thomas [Jr], to Troops Stationed for the defense of the frontier Settlements in the late War – Which provisions he bought and paid for with his own money, or property, having acted as a Commissary by the order of Col. Thomas, as aforesaid, and for which services as a Commissary, he never charged the public one shilling, but only charged for the provisions which he bought, and for which he was obliged to pay with his own Estate, for the good of the Service; the whole of which is included in the two Accounts above mentioned, entitled Supplies to the Army, for which he never received any pay, or compensation, either directly or indirectly – That the horse appraised at £150 as aforesaid, was taken from him by the Indians or Tories, or both, as well as he can recollect, about the month of April 1781, when he went on duty, with a command of Men, in pursuit of a party of Indians & Tories who had made an excursion on the frontier Settlements near where he was on duty with his Company at that time – That in the Indian Country, at that time, his said horse, with eight others were stole by the

Enemy: Which said horse he never got, nor received any pay or compensation for him, notwithstanding his best endeavors to get his said horse, or obtain his value from the public which he thought in justice he had a right to receive that the said horse was appraised by two freeholders upon oath at £150 as charged in the said account.
