[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable Jacob Read Esquire speaker of the Honorable House of Assembly now met &

Your Petitioner most humbly Sheweth,

That after the British took possession of this State [Charleston South Carolina fell to the British on May 12, 1780] your petitioner's father [Dr. Aaron Gillett]<sup>2</sup> & himself went into North Carolina with a party of Militia & there met General Gates [Horatio Gates] & Joined the Continental Troops. His father & himself had appointments in the Hospital his father was appointed Senior Surgeon & himself a Mate. Their appointments were given by the Director of said Hospitals, & approved of by General Gates. They remained doing their duty till after the Battle of Eutaw Springs [September 8, 1781] when a number of Hospital Surgeons coming out of Charles Ton [Charleston] & new arrangements taking place from Congress your petitioner's, father & himself was deranged & on inquiry of the Agent from Congress who Settled Accounts in Charleston, they were informed that by some resolve of Congress they must apply to the State for their Emoluments or Commutation.

Your petitioner had prepared a petition to this Honorable House last sitting but was advised as there was such a multiplicity of Business to postpone the petition till this meeting. He further Begs the attention of this house to sundry Accounts belonging to his deceased father which owing to deaths could not be so Clearly proved as the Auditor of Accounts required which your petitioner has since gotten evidence to Corroborate the Facts, which he hopes will make good his Claim, he prays a Committee may be appointed to Examine the Accounts –

Your petitioner from a retrospective back to the Services done by his father & himself Together with the Emense [Immense] losses they have sustained during the Contest, he hopes will actuate this Honorable House to grant that his father & himself may have their Commutations allowed them for their Services, and an order for that purpose and your petitioner will in duty bound ever pray.

[p 10] Gentlemen

June 28, 1792

Owing to the great distance I live from the City of Charleston, I never knew that any arrangement had taken place for these demands against this State when proper Vouchers had not been produced which Situation my Father's estate is in. We have considerable [evidence?] which I have Sufficient Vouchers to authenticate. I flatter myself it will be in the power of the present Commissioners knowing of my Claim not to allow my papers being excluded by the time they are Notarized. The Bearer of this Captain Bostick can inform you that I never knew a sentence of the affair till last Evening when I was sixty miles from the Vouchers. I shall take the most early opportunity of sending them down, the Papers.
