Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

That your Petitioner has never received any Compensation for his services,


That his being blown up in action has nearly deprived him of his Sight & has totally disqualified him from following his occupation to obtain subsistence.

Therefore even so small attention to him will be received out only as due, but as a Benevolence to a Blind Cripple, who did his Duty with Fidelity to this State.

And your Petitioner as in duty bound will ever pray.

Report – that they have maturely investigated the subject matter contained in the Petition of D. McCarthy, late a Seaman on board the Brigantine Privateer *Notre Dame*, belonging to this State, and find the allegations therein contained to be true, –

Your Committee, considering the distressed situation of the Petitioner, and that he is rendered incapable of gaining a livelihood, occasioned by wounds received in the service of this State, are unanimously of opinion that he be allowed the same annual pension, as was allowed the disabled Soldiers, late in the service of this State.

I Daniel McCarthy do hereby Constitute and Appoint, Calvin Spencer of the County and State aforesaid my lawful Attorney to receive on my behalf of the Commissioners of the Treasury of the State aforesaid, for the year 1792 – In testimony whereof I have hereunto set my hand and seal this 12th day of September 1792
