Pension application of David (Daniel?] Fannin [Va.5]¹ Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Served in Revolutionary War. Applied for pension on August 13, 1832. (Note - I believe that the Daniel in the first line is a mistake and it should have been David. David is mentioned two times in the document. Also – there was a David Fannin who lived there not Daniel.)

Daniel Fannin filed in open court the following declaration in order to obtain a pension and on being sworn to the in open court to the Truth of the same it is admitted Record and is in these words lowd(?). State of Indiana. Floyd County. On this thirteen day of August 1832 personally appeared before the Probate Court of the County of Floyd. Aforesaid David Fannin, a resident of Greenville Township in the County of Floyd State of Indiana aged seventy three years on the three day of August 1832 who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7 1832 - that enlisted in the army of the United States in the year 1776 or 1777 with Capt. John Montgomery and served in the regiment of the volunteers under the following officers: Col. William Russell, Maj. Anthony Bletcher and Maj. Evan Shelby, Capt. John Montgomery, Lieut. Michael Daugherty, Ensign Simson and was discharged in the fall of 1777 or 1778. He resided in Montgomery County State of Virginia when he entered into the service. He marched from Montgomery Co to ______ fort thence to ______ he was left _____ where he joined General Christ when he was left to guard the _____. He hereby relinquishes every claim whatever to a pension or any annuity except the present and he declares as his name is not on the pension roll of any agency in any state.

And the said Court do hereby declare their opinion that the above named applicant was a revolutionary soldier and served as he states.

¹ This application evidently was never filed with the War Department, or, if filed, was lost as there is no record of it in the National Archives. Presumably, the original application can be found in the court records of the Floyd County, Indiana, the place in which the applicant appears to have lived at the time he filed his application.
