Pension Application of Julius Gibbs W10055 Caty Gibbs

The declaration of Julius Gibbs in order to obtain the Benifit of the act of Congress of the 7<sup>th</sup> of June 1832 – On this 20<sup>th</sup> day of August 1832 Julius Gibbs personally appeared before the Justices of the County Court of Scott County Resident of s'd County & State of Kentucky aged Seventy nine since the 27th of March last being first duely sworn according to Law doth on his oath make the following declaration in order to obtain the benifit of the act of Congress of the 7<sup>th</sup> June last that he was resident & Citizen of the County of Culpepper [sic: Culpeper], State of Virginia, in the year 1775 when in the month of Sept. of that year he enlisted in the Military Service of the state of Virginia under Capt John Green of Culpepper afors'd for the term of one year & marched to Williamsburgh [sic: Williamsburg] & was attached to the first Va. Regt under command of Patrick Henry who was succeeded by Col Christy [William Christian] when s'd Henry was appointed Gov. that he faithfully served out the term of one year as aforesaid. He was among the Number who was stationed at the last mentioned point during the whole year to guard it from Gov. dunmore that he was honorably discharged which he has lost long since; he can not say who signed the discharge at this late period – that he also served 3 militia tours of two months each – one in 1777 he was marched to Pensylvania & was stationed on the waters of the Schuylkill – including Sept & Oct of that year Commanded by Capt E. Rucker under Maj'r. Roberts & Col [Philip] Pendleton who commanded all the mitia at that time & place The other tour at Hunters ford 1779 Stafford County under Capt Rob't Allcock [Robert Allcock], does not recollect Maj'r or Col. Genl. Wedon [sic: George Weedon] commanded all. the other tour 1781 at many points in the month of June & July under Capt Wood, Maj'r. declumer a Frenchman [sic: Christian Charles De Klauman, a Dane] & Col Robt. Allcock commanded the corps It would be too tedious to mention the marches of the mitia during this last tour. This tour is proven by his two witnesses Mr Slapp [Achilles Stapp (Slapp), pension application W599] & Mr Twyman [Reuben Twyman S31443]

## NOTES:

On 16 Oct 1839 Caty Gibbs, aged 79 years and one month, of Callaway County MO, applied for a pension stating that she married Julius Gibbs on 2 Dec 1785, and he died on 26 July 1834.

The file includes a family record certified as follows and transcribed below: "I Churchill J. Gibbs do solemly swear the annexed family Recod has been in my Father Julius Gibbs (as mentioned in the accompanying affidavits of myself and Caty Gibbs) possession since my earliest recollection (upwards of twenty years) untill his death in 1834 and since which time the same has been in my possession." Julius Gibbs was married to his wife Aggy Gibbs Dec'r the 27 in the year of our Lord 1779 Betsey Gibbs the Daughter of Julius Gibbs and Aggy his wife was born November the 18 1780 Milley Gibbs was born June the 30 1782

Aggy Gibbs the wife of Julius Gibbs Departed this life June the 9 1784

Julius Gibbs was Married to his wife Caty Gibbs in the year of our Lord December the 2 1785

James Gibbs was born AD October the 13 1786

John Gibbs was born AD December the 25 1787

Polley E Gibbs was born AD December the 18 1791

Robert F Gibbs was born AD August the 20 1794

Churchill J Gibbs was born AD January the 31 1797

Samuel C Gibbs was born AD February the 1 1800

Judith C Gibbs was born AD September the 19 1802
