Pension application of Moses Grigsby ¹ W10069 Abigail Grigsby f64VA Transcribed by Will Graves 6/6/14

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia, Stafford County to wit

On the 10th day of October 1820 personally appeared in open Court – being a Court of Record, being so by law for the County aforesaid, Moses Grigsby, aged fifty-seven years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the first of March 1818 & the first of May 1820, – that the said Moses Grigsby enlisted for the term of 3 years on the __ day of November in the year 1781 in the State of Virginia in the Company commanded by Captain Abram Fitzpatrick, in the Regiment commanded by Colonel Haws [Samuel Hawes] in the Line of the State of Virginia, on the Virginia Continental establishment; that he continued to serve in the said Corps until May 1783 when he was furloughed (to be called for but was never called for) in the state of Virginia. And that he has no other evidence now in his power of his said services, except Newton Philips & Vincent Bussle [?].

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, viz. one Horse, one Cow & calf, two sets of iron Traces, two sets of Gear, one Dagon plough, one Shovel plow, one Coulter, one Bull-tongue, one chest, three hoes, one spinning wheel, one pair of steelyards, one pot oven, Skillet & frying pan, one Clivis & three Swingletrees & one Matock [mattock] (the whole valued by the court at \$91.84) I do further certify that my occupation is that of a farmer or planter, and that the number of my family consist of my wife Abby, aged 58, & two daughters Abby & Frances the one aged twenty-six & the other twenty years, and a small child, the daughter of the aforesaid Frances aged three years.

Vincent Bussle and Newton Philips appear in court & being sworn for the purpose depose that they knew of the enlistment of Moses Grigsby and of his performing the service as set forth in his declaration.

State of North Carolina, Caswell County: Court of pleas & Quarter Sessions January 7, 1821 On the 10th day of January 1822, personally appeared in open Court of the County aforesaid (which is a Court of Record made so by the laws of this State) Moses Grigsby aged 59 years [2 or more indecipherable words], who being duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 & the 1st of May 1820 – that the said Moses Grigsby enlisted for the term of three years on the __day of November in the year 1781, in the State of Virginia in the Company commanded by Captain Abraham Fitzpatrick in the Regiment commanded by Colonel Haws in the line of the State of Virginia on the Continental establishment – that he continued to serve in said Corps until May 1783 when he was furloughed to be called for but was never afterwards called for in the said State of Virginia: and that he has no other evidence now in his power of his services except Newton Philips & Vincent Bussle's affidavits, which have been taken & attached to his declaration before made in Stafford County in the State of Virginia, where the witnesses now reside & where this deponent formally lived, but from whence he moved & now resides in the County of Caswell & State aforesaid; which said declaration and affidavits aforesaid he attached to this declaration.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed viz.

all of which property is valued by the court at \$73.50 & I do further declare on oath that my occupation is that of a farmer or planter & that my family consists of my Wife Abby aged about 59 & of [2 indecipherable words] one daughter Abby, aged about 21 years & a small child, the daughter of one of his daughters, who is now dead aged about 4 years – & that he is poor & stands in need of the assistance of his Country for his support.

[p 25: Application for a transfer of pension benefit dated February 24th, 1838 filed in Gibson County Indiana by the veteran describing himself as being formally a member of the company

commanded by Captain Fitzpatrick in the Regiment commanded by Colonel Samuel Hawes. He states his reason for moving from North Carolina to Indiana was to reside with his children. He signed this document with his mark.]

[p 11: On August 10, 1840 in Marion County Indiana, Abigail Grigsby, aged 79 years on the 24th of November next, made application for a widow's pension under the 1838 act stating that she is the widow of Moses Grigsby who was a pensioner of the United States of the North Carolina agency, and later transferred to the Indiana agency before his death; that she married him in Stafford County Virginia about two weeks before Christmas 1784 being about the 11th day of December; that she was then twenty-three years of age; that her husband died June 16, 1838 in Gibson County Indiana; that she has no family record nor does she believed that her husband recorded the ages of their children; that the best evidence she can produce is that her eldest daughter, now dead, was born in September 1785 and she was married prior to the birth of that child, Nancy Grigsby. She signed her application with her mark.]

[p 15: On June 4, 1855 in Dallas County Iowa, Abigail Grigsby, 96, filed for her bounty land entitlement as the widow of Moses Grigsby; in this document she states that her name prior to her marriage was Abigail Fritter [?]²

[p 17: Certified copy of the marriage record in Stafford County Virginia reading as follows: "1785 December Moses Grigsby to Abby dauter [daughter] Moses Fritter."]

[Veteran was pensioned at the rate of \$8 per month commencing October 10, 1820, for service as a private for 3 years in the Virginia Continental line. His widow was initially pensioned at the rate of \$56.66 per annum increased on March 1, 1848 to \$96 per annum.]
